C A P. XVII.

AN ACT relating to Inspectors of Flour.

(22d March, 1825.)

Preamble.

Inspectors of
Flour entitled
to demand 3d
in lieu of 2d
per Barrel.

WHEREAS it is expedient to augment the Fees allowed to Inspectors of Flour: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled, "*An Act for making more effectual provision for the Government of the Province of Quebec, in North-America,*" and to make further provision for the Government of the said Province;" And it is hereby enacted by the authority of the same, that from and after the passing of this Act, the Inspectors of Flour in this Province shall be entitled to demand and receive, for the Inspection of Flour and Branding the Barrels as by Law prescribed, the sum of three-pence, currency, and no more, per barrel, instead of two-pence, as allowed by an Act passed in the second year of His Majesty's Reign, intituled, "An Act to provide for the better Inspection of Flour."

Continuance

II. And be it further enacted by the authority aforesaid, that this Act shall be and remain in force until the first day of May, one thousand eight hundred and twenty-eight, and no longer.

C A P. XVIII.

AN ACT to continue for a limited time two Acts therein-mentioned, relating to the Inspection of Fish and Oil intended for exportation.

(22d. March, 1825.)

Preamble.

WHEREAS it is expedient to continue further, for a limited time, an Act passed in the Third Year of His Majesty's Reign, intituled, "An Act to provide for the Inspection of Fish and Oil intended for exportation, from the Ports of Quebec and Montreal," as also an Act passed in the Fourth Year of His Majesty's Reign, intituled, "An Act to extend the provisions of a certain Act therein-mentioned, relating to the Inspection of Fish and Oil, intended for exportation," the duration of which said Acts respectively is limited until the first day of May, one thousand eight hundred and twenty-five; Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled "An Act for making more effectual provision for the Government of the Province of Quebec, in North America," and to make further provision for the Government of the said Province;" And it is hereby enacted by the authority of the same, that the said Act passed in the Third Year of His Majesty's Reign, intituled, "An Act to provide for the Inspection of Fish and Oil, intended for exportation from the Ports of Quebec and Montreal," and the said Act passed in the fourth year of the Reign of His Majesty, intituled, "An Act to extend the provisions of a certain Act therein-mentioned, relating to the Inspection of Fish and Oil, intended for exportation," and all and every the matters and things in the said Acts severally mentioned and contained, shall continue to be and remain in force until the first day of May, one thousand eight hundred and twenty-seven, and no longer.
