## CAP. XI.

AN ACT to appropriate a certain sum of Money therein-mentioned for the support of the Emigrant Hospital, in Quebec.

#### (22d March, 1825.)

#### MOST GRACIOUS SOVEREIGN,

Preamble.

THEREAS it is expedient to appropriate a sum of money towards the relief of Indigent Sick Emigrant relief of Indigent Sick Emigrants arriving at Quebec from the United-Kingdom, as well as for other Indigent Sick Persons labouring under contagious Diseases ; May it therefore please Your Majesty, that it may be enacted, and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain, intituled, " An Act to " repeal certain parts of an Act passed in the fourteenth year of His Majesty's " Reign, intituled, " An Act for making more effectual provision for the Go-" vernment of the Province of Quebec, in North America," and to make fur-" ther provision for the Government of the said Province ;" and it is hereby enacted by the authority of the same, that from and after the passing of this Act, it shall be lawful for the Governor, Lieutenant-Governor, or Person administering the Government of the Province for the time being, by a Warrant or Warrants under his hand, from time to time, as occasion may require, to advance from and out of any appropriated in the hands of the Receiver-General of the Province, during the present year one thousand eight hundred and twenty-five, towards the support of the Hospital actually established in the City of Quebec, for the relief of Indigent Sick Emigrants from the United-Kingdom, and towards defraying certain arrears due to the Quebec Bank, for advances by the said Bank made towards the said Hospital a sum, not exceeding in the whole the sum of seven hundred pounds, currency, from and out of which said sum, the

£700 granted for the support of the Emigrant Hospital at Que.bec and for defraying certain arrears due to the Quebec Bank, for advances by the said Bank, made towards the said Hospital.

the sum of fifty-seven pounds currency, with the interest accrued, and to accrue thereupon, shall be refunded to the said Quebec Bank, or to the Cashier of the said Bank for the use thereof, and in discharge of so much remaining due to the said Bank, for advances made to the aforesaid Hospital.

3d, 4th, 5th & 6th clauses of the Act 4, Geo. IV. cap. 32, continued with respect to the said [Act A.ct.

II. And be it declared and further enacted by the authority aforesaid, that the second, third, fourth, fifth, and sixth Clauses or Sections of an Act of the Legislature of this Province, passed in the fourth year of His Majesty's Reign, intituled, " An Act to appropriate a certain sum of Money therein-mentioned, towards " the support of the Emigrant Hospital established in Quebec," and all and propriation made by this every the matters and things therein respectively mentioned and contained, shall further continue to be and remain in force with respect to the said Hospital, and to the appropriation made by this Act, until the first day of May, one thousand eight hundred and twenty-six.

III. And be it further enacted by the authority aforesaid, that the due application of the Monies by this Act appropriated, shall be accounted for to His Majesty, his Heirs and Successors, through the Lords Commissioners of His Majesty's Treasury for the time being, in such manner and form, as His Majesty, his Heirs and Successors shall be pleased to direct.
