THEREAS it is expedient to augment the Fees allowed to Inspectors of Flour: Bc it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain, intituled, "An Act to repeal certain parts of an Act passed in the four-" teenth year of His Majesty's Reign, intituled, " An Act for making more " effectual provision for the Government of the Province of Quebec, in North-" America," and to make further provision for the Government of the said Pro-" vince;" And it is hereby enacted by the authority of the same, that from and after the passing of this Act, the Inspectors of Flour in this Province shall be entitled to demand and receive, for the Inspection of Flour and Branding the Barrels as by Law prescribed, the sum of three-pence, currency, and no more, per barrel, instead of two-pence, as allowed by an Act passed in the second year of His Majesty's Reign, intituled, "An Act to provide for the " better Inspection of Flour."
