## An Act still further to continue for a limited time certain Acts therein-mentioned, relating to Houses of Correction in the several Districts of this Province. (22d. March, 1825.)

Whereas it is expedient still further to continue for a limited time, an Act passed in the fifty-seventh year of the Reign, of His fate Majesty George the Third, intituled, "An Act to provide temporary Houses of Correction in the several Districts of this Province," as amended by an Act passed in the fifty-eighth year of His late Majesty's Reign, intituled, "An Act to amend an Act passed in the fifty-seventh year of His Majesty's Reign, intituled, 'An Act to provide temporary Houses of Correction in the several Districts of this Province and for other purposes," the duration of which Acts is limited to the first day of May, One thousand eight hundred and twenty-five: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth vear of His Majesty's Reign, intituled, 'An Act for making more effectual provision for the Government of the Province of Quebec, in North America,' and to make further provision for the Government of the said Province;" and it is hereby enacted by the authority of the same, that the above recited Act passed in the fifty-seventh year of His late Majesty's Reign, intituled, "An Act to provide temporary Houses of Correction in the several Districts of this Province," as amended by the said Act, passed in the fiftyeighth year of His late Majesty's Reign, intituled, "An Act to amend an Act, passed in the fifty-seventh year of His Majesty's Reign, intituled, 'An Act to provide temporary Houses of Correction in the several Districts of this Province, and for other purposes," and all and every the matters and things in the said Acts respectively mentioned and contained, shall still further continue to be and remain in force until the first day of May, one thousand eight hundred and twenty-seven, and no longer; all and every the sums of Money therein-mentioned and appropriated, shall, annually, during the further continuance of the said Acts, be advanced and paid for the purposes thereof, and in the proportions specified for each of the Districts therein-mentioned, and shall be accounted for in the manner as in and by the said Acts it is mentioned and provided.

II. And whereas it is expedient further to continue for a limited time an Act passed in the third year of the Reign of His Majesty, intituled, "An Act to extend certain provisions contained in an Act passed in the fifty-seventh year of the Reign of His late Majesty, intituled, 'An Act to provide temporary Houses of Correction in the several Districts of this Province,'" the duration whereof is limited to the first day of May, one thousand eight hundred and twenty-five; Be it therefore further enacted by the authority of the same, that the said Act passed in the third year of His Majesty's Reign, intituled, "An Act to extend certain provisions contained in an Act passed in the fifty-seventh year of the Reign of His late Majesty, intituled, "An Act to extend certain provisions contained in an Act passed in the fifty-seventh year of the Reign of His late Majesty, intituled, 'An Act to provide Temporary Houses of Correction in the several Districts of this Province,''' shall further continue to be and remain in force until the first day of May, one thousand eight hundred and twenty-seven, and no longer.
