CAP. XXIV.

An Acr to authorize the Chairman and Trustees of the Common of Three-Rivers, to acquire and grant certain lots of ground thereinmentioned.

(29th March, 1826.)

Preamble.

HEREAS the Chairman and Trustees of the Common of the Town of Three-Rivers, have by their Petition to the Legislature prayed for certain powers to enable them to effect for the public advantage of the Inhabitants of the Town of Three-Rivers, certain purposes in their aforesaid Petition specified, and which powers it is expedient to grant : Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "AnAct to repeal certain parts of an Act " passed in the fourteenth year of His Majesty's Reign, intituled, " An Act for " making more effectual provision for the Government of the Province of Quebec, " in North America," and to make further provision for the Government of " the said Province;" and it is hereby enacted by the authority of the same, The Chairman that it shall from and after the passing of this Act, be lawful for the Corpora-The Chairman that it snail from and arter the passing of this tion, established at the Town of Three-Rivers, under the name of "The Chair-of the Common of Three- man and Trustees of the Common of the Town of Three-Rivers,' to concede rived to con-cede in town or grant in town lots, each lot not exceeding one half arpent in superficies, a loss a certain portion not to exceed in all thirty-six arpents in superficies of the Common of partion of the Rivers, for the purpose of prolonging the concession or ridge of town lots, as well on the North-West as South-East side of Saint Philip street, to the Wind-Mill, so as to afford an issue from the said street to the King's highway, and in like manner to continue or prolong one concession or lot only, from the extremity of Forge street, to the lot held by the representatives of the late

Provided always and be it further enacted by the authority aforesaid, that such concessions or grants shall only be made on the express condition, that the Grantees, and their several Representatives, or others holding the said Town lots, to be conceded or granted in virtue of the power conferred by this Act, shall respectively be held to make and maintain for all time to come, at their

Declared a public Act. And be it further enacted by the authority aforesaid, that this Act shall be deemed a public Act, and as such shall be judicially noticed by all Judges, Justices, and others whom it may concern, without being specially pleaded.
