MOST GRACIOUS SOVEREIGN.

Preamble.

HEREAS it is expedient to appropriate a certain sum of money for the purpose of repairing the Government House in the City of Montreal and of purchasing certain furniture for the same : May it therefore please your Majesty that it may be enacted, and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the LegislativeCouncil and Assembly of the Province of LowerCanada, constituted and assembled by virtue and under the authority of an Act passed in the Parliament of Great-Britain, intituled, "An Act to repeal "certain parts of an Act passed in the fourteenth year of His Majesty's Reign, "intituled, "An Act for making more effectual provision for the Government of "the Province of Quebec in North America," and to make further provision for

Clarke, of the said City, Architect, now in the hands of His Excellency the Governor in Chief, provided that no part of the said monies shall be so expended until good and sufficient security shall have been given to such Commissioners by some person or persons contracting to perform the same, that such repairs shall be completed for a sum not exceeding the said sum; and in like manner to advance a further sum not exceeding one thousand five hundred pounds currency, to defray theexpense of purchasing proper furniture to be placed in the said Government House, Provided always that such furniture shall be applied and used for no other purpose and shall II. be and remain the public property of the Province.

Every person entrusted with the expendi-j ture of any monies appropriated by this Act to account for the same.

II. And be it further enacted by the authority aforesaid, that every person to whom shall be entrusted the expenditure of any portion of the monies hereby appropriated, shall make up detailed accounts of such expenditure, shewing the sum advanced to the accountant, the sum actually expended, the balance (if any) remaining in his hands, and the amount of the monies hereby appropriated to the purpose for which such advance shall have been made, remaining unexpended in the hands of the Receiver General, and that every such account shall be supported by Vouchers therein distinctly referred to, by numbers corresponding to the numbering of the Items in such account, and shall be made up to and closed on the tenth day of April and tenth day of October, in each year, during which such expenditure shall be made, and shall be attested before a Justice of the Court of King's Bench, or a Justice of the Peace, and shall be transmitted to the officer whose duty it shall be to receive such account within fifteen days next after the expiration of the said periods respectively.
