An Act to continue, for a limited time, certain Acts therein-mentioned.

[25th February, 1832.]

Preamble.

WHEREAS it is expedient that the several Acts hereinafter-mentioned should be further continued and should remain in force during a limited time;—Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain, intituled, "*An Act for making more effectual provision for the Government of the Province of Quebec in North-America,*" and to make further provision for the Government of the said Province;"—And it is hereby enacted by the authority of the same, that a certain Act passed in the fifty-seventh year of the Reign of His Majesty King George the Third, intituled, "An Act to provide temporary Houses of Correction in the several Districts of this Province;" and a certain other Act passed in the fifty-eighth year of the said Reign, intituled, "An Act to amend an Act passed in the fifty-seventh year of His Majesty's Reign, intituled, "An Act to provide temporary Houses of Correction in the several Districts of this Province, and for other purposes;" and another

ther certain Act passed in the ninth year of His late Majesty's Reign, intituled, " An Act to revive and further to continue for a limited time, and to amend a certain Act passed in the fifth year of His Majesty's Reign, relating to Houses of Correction in the several Districts of this Province;" and a certain other Act passed in the ninth year of His late Majesty's Reign, intituled, " An Act to prevent the fraudulent seizure and sale of Lands and other real property within this Province;" and a certain other Act passed in the fourth year of His late Majesty's Reign, intituled, " An Act to authorize the sale and disposal of certain goods unclaimed and remaining in the hands of the Clerks of the Peace of this Province;" and the tenth Section of a certain Act passed in the fourth year of His late Majesty's Reign, intituled, " An Act to render valid certain Acts, Agreements in Writing, and Contracts of Marriage (*Contrats de Mariage sous seing privé*), heretofore executed in the Inferior District of Gaspé, and to provide for the want of Notaries in the said District;" which said Section was subsequently continued by two several Acts passed in the seventh and ninth years of His late Majesty's Reign, respectively; and a certain other Act passed in the tenth and eleventh years of the Reign of His late Majesty, intituled, " An Act further to continue for a limited time and to amend a certain Act therein-mentioned concerning the Police of the Borough of William Henry, and of certain other Villages in this Province," shall be and they are hereby continued and shall remain in force until the expiration of this Act and no longer.

II. And be it further enacted by the authority aforesaid, that this Act shall be and remain in force until the first day of May, one thousand eight hundred and thirty-five, and no longer.
