Preamble.

HEREAS it is expedient still further to continue, for a limited time, an Act passed in the seventh year of His Majesty's Reign, intituled, " An Act to continue and amend certain Acts therein-mentioned, establishing a "Watch and providing for the Lighting of the Cities of Quebec and Montreal," the duration whereof is limited to the first day of May, one thousand eight hundred and twenty-nine ; Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain, intituled, " An Act to repeal certain parts of an Act passed in the fourteenth " year of His Majesty's Reign, intituled, " An Act for making more effectual " provision for the Government of the Province of Quebec in North America," and " to make further provision for the Government of the said Province ;" And it is hereby enacted by the authority of the same, that the said Act passed in the seventh year of His Majesty's Reign, intituled, " An Act to continue and a-" mend certain Acts therein-mentioned, establishing a Watch and providing " for the Lighting of the Cities of Quebec and Montreal," and all matters and things therein-contained, shall further continue to be in force until the first day of May, one thousand eight hundred and thirty-one, and no longer.
