II. And be it further enacted by the authority aforesaid, that it shall be lawful for the Governor, Lieutenant Governor or person administering the Gvernment of the Province, to advance and pay to the Trustees of the School or Academy in the Parish of Assomption, a sum not exceeding three hundred pounds currency, which was appropriated for the said School, by the said Act of the first year of His Majesty's Reign, chapter seven, but has not yet been paid to them, because they had not complied with the provisions of the said Act.

III. And be it further enacted by the authority aforesaid, that every person to whom shall be entrusted the expenditure of every portion of the Monies hereby any period of appropriated, shall make up detailed accounts of such expenditure, shewing the breeby appro. sum advanced to the Accountant, the sum actually expended, the balance (if any) der a detailed remaining in his hands, and the amount of the monies hereby appropriated to the purpose for which such advance shall have been made, remaining unexpended in the hands of the Receiver General, and that any such account shall be supported by vouchers therein distinctly referred to, by numbers corresponding to the numbering of the items in such account, and shall be made up to and closed on the tenth day of April and tenth day of October in each year, during which said expenditure shall be made and shall be attested before a Justice of the Court of King's Bench, or a Justice of the Peace, and shall be transmitted to the Officer whose duty it shall be to receive such account, within fifteen days next after the expiration of the said periods respectively.

IV. And be it further enacted by the authority aforesaid, that the due application of the Monies appropriated by this Act shall be accounted for to His Ma. jesty, His Heirs and Successors, through the Lords Commissioners of His Majesty's Treasury for the time being, in such manner and form as His Majesty, His Heirs and Successors shall direct, and that a detailed account of the expenditure of all such Monies, shall be laid before the several branches of the Provincial Legislature within the first fifteen days of the next Session thereof.

TATHEREAS it is expedient to appropriate certain Sums of Money for the purposes hereinafter mentioned; May it therefore please Your Majesty that it may be enacted, and be it enacted by the King's most Excellent Majesty, C. 2].

## Anno tertio Gulielmi IV.

Certain of mouey granted and appropriated for certain expences of the Civil Government

by and with the advice and consent of the Legislative Council and Assembly of certain sums the Province of Lower Canada, constituted and assembled by virtue of, and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled, " An Act for making more effectual provision for the " Government of the Province of Quebec, in North America," and to make further " provision for the Government of the said Province," And it is hereby enacted by the authority of the same, that it shall be lawful for the Governor, Lieutenant Governor or person administering the Government of the said Province by Warrant under his hand, to take out of any unappropriated monies in the hands of the Receiver General a sum not exceeding sixty-nine pounds four shillings and two pence, sterling, to defray the excess of expense incurred for Postages for the Civil Secretary's Office during the year one thousand eight hundred and thirty-two. A sum not exceeding four pounds seventeen shillings and four pence sterling, to defray the excess of expence, incurred for extra writing in the Civil Secretary's Office during the same period. A sum not exceeding one hundred and seventyeight pounds eleven shillings and one penny sterling, to defray the excess of expence incurred in the Contingencies of the Sheriff of Quebec, during the same period. A sum not exceeding one hundred and twenty pounds one shilling and eleven pence sterling, to defray the excess of expence incurred in the Contingencies of the Sheriff of Three Rivers, during the same period. A sum not exceeding three pounds seven shillings and ten pence sterling, to defray the excess of expence incurred in the Contingencies of the Coroner of the District of Quebec, during the same period. A sum not exceeding nine pounds and eleven pence sterling, to defray the excess of expence in the Contingencies of the Coroner of the District of Montreal, during the same period. A sum not exceeding ten pounds and four pence sterling, to defray the excess of expence incurred in the Contingencies of the Prothonotaries of the District of Montreal, during the same period. A sum not exceeding eighty pounds seventeen shillings and two pence sterling, to defray the excess of expence incurred in the Contingencies of the Clerks of the Peace for the District of Quebec, during the same period. A sum not exceeding sixty-six pounds eighteen shillings and five pence sterling, to defray the excess of expence in the Contingencies of the Clerk of the Peace for the District of Three Rivers, during the same period. A sum not exceeding five hundred pounds eight shillings sterling, to defray the excess of expence incurred for Printing the Laws during the same period A sum not exceeding nineteen pounds ten shillings and two pence sterling, to pay to N. H. Joslin, his taxed account of expences incurred in executing a Warrant against several persons in the District of Montreal, in the year one thousand eight hundred and thirty. A sum not exceeding eighty-one pounds nineteen shillings and nine pence sterling, to pay Sir Rupert D. George, Provincial Secretary of Nova Scotia, for expences attendant upon the maintainance at Halifax and conveyance to Bermuda of five convicts sent from Quebec, in September one

one thousand eight hundred and thirty. A sum not exceeding sixteen pounds. thirteen shillings sterling, to pay Joseph Bouchette, Esq. Deputy Surveyor General, for the survey, Plans and Report concerning the Boundary Line, between the Crown and the Seminary of Quebec. A sum not exceeding two hundred and fifty-one pounds two shillings and nine pence sterling, to pay to William Smith Sewell, Esquire, Sheriff of the District of Quebec, for expences incurred in forming. Jury Lists, under the Act of the second year of His Majesty's Reign, chapter twenty-two. A sum not exceeding one hundred and sixty-six pounds eight shillings and six pence, sterling, to pay Louis Gugy, Esquire, Sheriff of the District of Montreal, for expences incurred in forming Jury Lists under the said Act. sum not exceeding one hundred and forty-eight pounds eighteen shillings and four pence sterling, to pay J. G. Ogden, Esquire, Sheriff of the District of Three Rivers, for expences incurred in forming Jury Lists under the said Act. A sum not exceeding twenty-six pounds thirteen shillings and eight pence sterling, to pay C. De Tonnancour the amount of his Contingent Account as Coroner for the Inferior District of Saint Francis, for the years one thousand eight hundred and thirty-one and one thousand eight hundred and thirty-two. A sum not exceeding one thousand three hundred and fifty pounds sterling, to defray the expences of the several Boards of Health established under the provisions of the Act of the second year of His Majesty's Reign, chapter sixteen, and for the Salaries of the Health Commissioners and resident Physicians, to the thirty-first day of January, one thousand eight hundred and thirty-three.
