Co is and expences may be included in such apportionment, to be paid by the Co-proprie fors to whom shares may have fallen.

XI. And be it further enacted by the authority aforesaid, that the said Commissioner shall and may include in such apportionment all other costs and expences which may then be lawfully due by the President and Trustees of the said Common, appointed by an Act, intituled, "An Act to regulate the Common of the Parish of Saint "Antoine, of the Riviere du Loup, in the County of Saint Maurice," and that the said Co-proprietors to whom shares shall have fallen by the partition above mentioned, shall on demand pay to the said Commissioner (after the publishing of the said apportionment comprising all the costs and sums due as beforementioned, at the Church door of the said Parish, on two Sundays or holidays immediately after Divine Service in the forenoon) the sum or sums which are or shall become due for each lot or share of ihe said Common.

Saving of the King's rights.

XII. And be it further enacted by the authority aforesaid, that nothing in this contained shall extend or be construed to extend to affect, diminish or destroy the rights and privileges of His Majesty, His Heirs and Successors, nor of any other person or persons, society or corporate body, excepting only such as this Act specially affects.

C A P. XXV.

An Act to establish a Fire Society in the Borough of Three Rivers, and to suspend two certain Ordinances as far as they relate to the said Borough.

[3d April, 1833.]

Preamble.

HEREAS it is expedient to provide more ample and efficacious means for preventing conflagration in the Borough of Three Rivers, and in case of conflagration, for more speedily arresting the progress thereof, and whereas divers inhabitants of the said Borough have by their Petition to the Legislature, prayed that a Fire Society may be established therein for the purposes aforesaid : Be it therefore enacted by the King's most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of, and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain

Ordinance passed in the 17 h year of Geo. III, and another Ordi. pance passed in the S0th year of that reiga, suspen. deri, while this Act is in force as far as they concern the Town or Po-Rivers.

A Fire So-ciety estab. lished in the Boreugh of Three Rivers, and to be governed by the provisions of Act 9th Geo. V. cap. 57, with the ex. ception of such parts as may be convary to this Act.

And be it further enacted by the authority aforesaid, that there shall be in the Borough of Three Rivers an Association which shall be called the "Fire " Society of Three Rivers," and that all the clauses, provisions and enactments of a certain Act passed in the ninth year of the Reign of His late Majesty George the Fourth, chapter fifty_seven, intituled, " An Act to suspend for a limited time, certain Ordinances therein mentioned, as far as the same relate to the City of Montreal, and to establish a Society therein for preventing accidents by " Fire," shall be and they are hereby with the exception of such parts thereof only as may be contrary to this Act extended, and shall be applicable to the said Borough and to the said Fire Society of Three Rivers, during the time this Act shall be in force : Provided always that no amendments made or to be made to the said Act by any subsequent Act, shall be so extended by of this Act.

> III. Provided always, and be it further enacted by the authority aforesaid, that the lists of proprietors from among whom the members of the said Society shall be chosen, shall be made by the Grand Jury of the General Quarter Sessions of the Peace, holden at the said Borough, in the month of July, and presented to the Justices of the Peace sitting in said Session. Provided also that the number of names contained in every such list shall be fourteen, and that the number of persons who shall be chosen by the said Justices to be members of the said Socie. ty shall be seven : Provided also that of the members appointed at the first general appointment, four shall remain in office during two years, and three during one year only, and the members of the said Society shall draw lots to determine which three members shall retire from office at the end of the first year : Provided also that the three or four (as the case may be) senior members shall every year retire from office and that their places shall be supplied in the manner prescribed by the said Provided also, that the resident judge of the District of Three Rivers, shall Act. in term or in vacation have all the powers with regard to the By-Laws, Rules and Regulations of the said Society, and to the repeal or amendment thereof given by

by the said Act to the Court of King's Bench with regard to the By-Laws, Rules and Regulations of the Fire Society thereby established ; but the same shall not be in force until they with the confirmation thereof, signed by the Prothonotary shall have been published in the newspaper published at Three Rivers (if any there shall then be) or if there be none, then in the Quebec Gazette printed by authority. Provided also that the number of volunteers to be assigned by the said Society to each Ward where there shall be Fire Engines, shall not exceed twenty-five for each large Engine, and ten for each small Engine, and that the Captain of each Ward shall (both in the first instance and in every case of vacancy) be chosen by the Volunteers assigned to the same, provided that if such Captain be not approved by the Society, another shall be appointed in his stead by the Society, at their then next meeting; and the Captain shall command such Ward. Provided also, that the Company of Volunteers formed by the Society, and who shall be present, and assist at every Fire, shall consist of twenty men and no more. Provided also that the number of Peace Officers to be appointed by the said Society to be present at fires, shall be six and no more. Provided also, that three members of the said Society shall in all cases form a quorum. Provided also, that three members of the Society shall with the concurrence of any two the inhabitants, being proprietors of real property in the said Borough, have the power of causing to be demolished or taken down all buildings and fences which they shall deem necessary to be demolished or taken down for arresting the progress of any fire, and that they shall not in consequence thereof be molested nor liable to any damages. Provided also that no inhabitant of the said Borough who shall have served as a member of the said Society, shall again be liable to serve as such at any time during the four vears immediately following his retirement from office. Provided also that the Secretary Treasurer shall be the Collector of the said Society. Provided also that the settlement of the accounts of the said Society shall be advertised in the newspaper then published in Three Rivers, or if there be none so published, then in the Quebec Gazette, published by authority. Provided also, that the number of Leathern Fire Buckets to be provided by the Society, shall be one hundred. Provided also that the objection to construct the gables of houses in the manner mentioned in the said Act, shall extend to all houses to be built of brick or stone in the said Borough, and not to those to be built of wood. Provided also that it shall be lawful for any person to build a dwelling-house in wood; but no person shall kindle any fire in any wooden building or shed, unless there be a chimney therein, under a penalty of two pounds currency. Provided also that the sum which the Overseer to prevent accidents by Fire for the said Borough, shall receive annually out of the Funds of the said Society, and be paid him on the order of the Chairman by the Secretary Treasurer, shall be twenty-five pounds currency and no more. Provided also, that the Borough of Three Rivers, for all the purposes of this Act, shall be understood to include all the ground within the limits of the Parish of Three Rivers, mentioned in the edicts or ordinances of His Most Christian Majesty, made on the third of March, in the year one thousand seven hundred and twenty-two. ٧ŀ

IV. And be it further enacted by the aforesaid, that this Act shall be in force until the first day of May, one thousand eight hundred and thirty-eight, and no longer.

An Act to make further provision for the improvement of the Internal Communications of this Province.

HEREAS the further improvement of the Internal Communications of the Province, will materially contribute to facilitate the formation of new Settlements, and tend to promote Agriculture and Commerce, We, Your Majesty's most dutiful and loyal Subjects, the Commons of Lower Canada, most humbly pray Your Majesty, that it may be enacted, and be it enacted by the King's Most Excellent Majestv, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed " in the fourteenth year of His Majesty's Reign, intituled, "An Act for making " more effectual provision for the Government of the Province of Quebec, in North America," and to make further provision for the Government of the said Province ;" £8505 19 8, And it is hereby enacted by the authority of the same, that it shall be lawful for granted for the Governor Lieutent Governor or person administering the Government of the purposes of this Act. Province to advance and pay by Warrant under his hand, and out of any unappropriated monies in the hands of the Receiver General, a sum not exceeding eight thousand three hundred and five pounds nineteen shillings and eight pence currency, to be applied to the improvement of the Inland Communications of the How distri-Province, in the manner following, that is to say :- Counties of Rimouski and Bonaventure, a sum not exceeding twenty-five pounds currency annually. to Pierre-Brochu, during three years, and a like sum during a like term, to any three other persons who shall actually establish themselves on the Kempt Road, from Metis to Ristigouche-that is to say, one person at a distance of about eighteen or twenty miles from the said Pierre Brochu, at the place called Petit Lac, another five or six miles lower down than the place called the Forks, and the third half way between the last mentioned person and the River Ristigouche; Provided always that such allowance shall be paid to the said Pierre Brochu and the other persons at the
