

## CAP. VI.

An Act to amend an Act of the ninth George the Fourth, chapter seventy-three, subdividing the Province into Counties, by establishing new places of Election in certain Counties therein mentioned.

[18th March, 1834.]

Preamble.

**W**HEREAS it is expedient to amend the Act passed in the ninth year of the Reign of His late Majesty, George the Fourth, chapter seventy-three, intituled, "An Act to make a new and more convenient subdivision of the Province into Counties, for the purpose of effecting a more equal representation thereof, in the Assembly, than heretofore," by appointing an additional place of Election in each of the Counties hereinafter mentioned:—Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled, "*An Act for making more effectual provision for the Government of the Province of Quebec in North America,*" and to make further provision for the Government of the said Province;" And it is hereby enacted by the authority of the same, that there shall be a second place of Election in the County of Rouville, and that such second place shall be at Henry-Ville, in the said County.

II. And be it further enacted by the authority aforesaid, that there shall be a second place of Election in the County of Ottawa; and that such second place of Election shall be at some convenient spot on the right bank of the River *Petite Nation*, at or near the point where the high road intersects the said River, in the Seigniorship of *Petite Nation*, in the said County.

III. And be it further enacted by the authority aforesaid, that there shall be a second place of Election in the County of Shefford, and that such second place shall be at or near the School House in the School District, number three, in the Township of Farnham, in the said County.

A second place of Election fixed for the County of Megantic, to be held at the School House in Ireland.

IV. And be it further enacted by the authority aforesaid, that there shall be a second place of Election in the County of Megantic; and that such second place of Election shall be at or near the School House in the School district, number two, in the Township of Ireland, in the said County.

County Elections to commence at the place appointed by the Act hereinbefore cited and amended, and at the places fixed by this Act.

V. And be it further enacted by the authority aforesaid; that in each of the Counties aforesaid respectively, the Election shall commence at the place of Election appointed for such County by the Act hereinbefore cited and amended, and at the place of Election appointed by this Act, alternately, and may be removed to the other place of Election for such County, in conformity to the provisions of the twelfth Section of an Act passed in the fifth year of the Reign of His late Majesty, George the Fourth, chapter thirty-three, intituled, "An Act to repeal certain Acts therein mentioned, and to consolidate the Laws relating to the Election of Members to serve in the Assembly of this Province, and to the duty of Returning Officers, and for other purposes," if such removal shall be required in the manner and form prescribed by the said Act: Provided always, that the next Election for each of the said Counties respectively, shall commence at the place of Election appointed for such County, by the Act herein first above cited and amended.

## CAP. VII.

An Act to make more ample provision for the encouragement of Agriculture.

[18th March, 1834.]

MOST GRACIOUS SOVEREIGN.

Preamble.

**W**HEREAS it is expedient to provide more amply for the encouragement of Agriculture in this Province: May it therefore please Your Majesty that it may be enacted, and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of Act passed in the fourteenth year of His Majesty's Reign, intituled, "*An Act for making more effectual provision for the Government of the Province of Quebec in North America,*" and to make further provision for the Government of the said Province;" And it is hereby enacted by the authority of the same, that from and after the passing of this Act, an Agricultural Society may
