4 William IV - Chapter 9

An Act to continue certain Acts therein mentioned. (18th March, 1834.)

Whereas it is expedient to continue certain Acts which would otherwise expire on the first fifteenth of May, one thousand eight hundred and thirty-four:—Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled, 'An Act for making more effectual provision for the Government of the Province of Quebec in North America,' and to make more effectual provision for the Government of the said Province;" and is is hereby enacted by the authority of the same, that a certain Act passed in the forty-eighth year of the Reign of George the Third, chapter twenty-one, intituled, "An Act to regulate the trial of controverted Elections," which would otherwise expire on the first day of May next, shall continue to be in force as amended and continued by the Act of the ninth year of the Reign of George the Fourth, chapter sixty-one, until the first day of May, one thousand eight hundred and thirty-six, and thence until the end of the then next Session of the Provincial Legislature, and no longer.

- II. And be it further enacted by the authority aforesaid, that a certain other Act passed in the fifty eighth year of the Reign of George the Third, chapter two, intituled, "An Act to provide more effectually for the security of the City of Quebec and Montreal, by establishing Watch and Night Lights in the said Cities and for other purposes: and which provides the means of defraying the expenses thereof," which Act would otherwise expire on the first day of May next, shall continue to be in force, (as continued by the Act of the first year of the Reign of His Majesty William the Fourth, chapter thirty-four,) until the first day of May, one thousand eight hundred and thirty-six, and no longer.
- III. And be it further enacted by the authority aforesaid, that a certain other Act passed in the second year of the Reign of George the Fourth, chapter five, intituled, "An Act to extend the provisions of a certain Act therein mentioned, as far as the same relates to the Judicature in the Inferior District of Gaspe, and more effectually to provide for the due administration of Justice in the said District," and a certain other Act passed in the fourth year of the Reign of His late Majesty George the Fourth, chapter seven, intituled, "An Act to amend a certain Act therein mentioned and further to extend the Jurisdiction of the Provincial Court for the District of Gaspe," as the same are continued and amended by a certain other Act passed in the sixth year of His late Majesty's Reign, chapter twenty-five, intituled, "An Act to amend and continue for a limited time two certain Acts therein mentioned, relating to the Judicature in the Inferior District of Gaspe," as the same are

further continued and amended by a certain other Act passed in the second year of His Majesty's Reign, chapter fifty, intituled, "An Act to continue and to amend certain Acts relating to the Judicature of the Inferior District of Gaspe," which Acts would otherwise expire on the first day of May next, shall continue in force until the first day of May, one thousand eight hundred and thirty-six, and no longer.

- IV. And be it further enacted by the authority aforesaid, that a certain other Act passed in the third year of the Reign of George the Fourth, chapter sixteen, intituled, "An Act to provide for the Inspection of Fish and Oil intended for exportation from the ports of Quebec and Montreal," and a certain other Act passed in the fourth year of His late Majesty's Reign, chapter twenty-three, intituled, "An Act to extend the provisions of a certain Act therein mentioned relating to the Inspecion of Fish and Oil, intended for exportation," as revived and continued by a certain other Act passed in the second year of His Majesty's Reign, chapter four, intituled, "An Act to revive and continue for a limited time two certain Acts therein mentioned relating to the Inspection of Fish and Oil, intended for exportation," which Acts would otherwise expire on the first day of May next, shall be and continue in force, until the first day of May, one thousand eight hundred and thirty-six, and no longer.
- V. And be it further enacted by the authority aforesaid, that a certain other Act passed in the seventh year of the Reign of George the Fourth, chapter three, intituled, "An Act more effectually to provide for the maintenance of good order in Churches, Chapels, and other places of Public Worship, and for other purposes therein mentioned," which Act would otherwise expire on the first day of May next, shall continue to be in force, until the first day of May, one thousand eight hundred and thirty-six, and no longer.
- VI. And be it further enacted by the authority aforesaid, that a certain other Act passed in the seventh year of the Reign of George the Fourth, chapter, eleventh, intituled, "An Act to provide regulations concerning the Beaches and Landing Places in Quebec," as amended and continued by a certain other Act passed in the second year of His Majesty's Reign, chapter nine, intituled, "An Act to continue for a limited time and to amend, An Act passed in the seventh year of His Majesty's Reign, intituled, 'An Act to provide regulations concerning the Beaches or Strands and Landing Places in Quebec,'" which Acts would otherwise expire on the first day of May next, shall continue to be in force, until the first day of May, one thousand eight hundred and thirty-six, and no longer.
- VII. And be it further enacted by the authority aforesaid, that a certain other Act passed in the ninth year of the Reign of George the Fourth, chapter seven, intituled, "An Act further to regulate persons who keep Houses of Public Entertainment and retail spirituous liquors, and for other purposes," as amended and continued by a certain Act passed in the first year of His Majesty's Reign, chapter nine, intituled, "An Act to amend and continue for a limited time a certain Act passed in the ninth year of the Reign of His late Majesty, intituled, 'An Act further to regulate persons who keep Houses of Public Entertainment and retail spirituous liquors, and for other purposes,'" as the same are further amended by a certain other Act made and passed in the second year of His Majesty's Reign, chapter nineteen, intituled, "An

Act to amend a certain Act passed in the first year of His Majesty's Reign, for regulating Tavern Keepers," which would otherwise expire on the first day of May next, shall continue to be in force, until the first day of May, one thousand eight hundred and thirty-six, and no longer.

VIII. And be it further enacted by the authority aforesaid, that a certain other Act passed in the ninth year of the Reign of George the Fourth, chapter sixteen, intituled, "An Act to increase the number of assessors for the cities of Quebec and Montreal," which would otherwise expire on the first day of May next, shall continue to be in force until the first day of May, one thousand eight hundred and thirty-six, and no longer.

- IX. And be it further enacted by the authority aforesaid, that another certain Act passed in the ninth year of the Reign of George the Fourth, chapter twenty, intituled, "An Act to provide for the more effectual extinction of Secret Incumbrances on Lands, than was heretofore in use in this Province," the duration of which is limited to the first day of May next, and thence until the end of the then next Session, shall continue to be in force until the first day of May, one thousand eight hundred and thirty-six, and no longer.
- X. And be it further enacted by the authority aforesaid, that another certain Act passed in the ninth year of the Reign of George the Fourth, chapter fifty-one, intituled, "An Act for the preservation of the Salmon fisheries in the Counties of Cornwallis and Northumberland," which would otherwise expire on the first day of May next, shall continue to be in force until the first day of May, one thousand eight hundred and thirty-six, and no longer.
- XI. And be it further enacted by the authority aforesaid, that a certain other Act passed in the tenth and eleventh years of the Reign of George the Fourth, chapter three, intituled, "An Act to provide for the better defence of the Province, and to regulate the Militia thereof," which would otherwise expire on the first day of Mav next, shall continue to be in force until the first day of Mav, one thousand eight hundred and thirty-six, and no longer.
- XII. And be it further enacted by the authority aforesaid, that another certain Act passed in the first year of the Reign of His Majesty William the Fourth, chapter two, intituled, "An Act to facilitate the administration of Justice respecting Enquotes in Civil Matters, before the Court of King's Bench, for the Districts of Quebec, Montreal and Three Rivers, and Inferior District of Saint Francis," which would otherwise expire on the first day of May next, shall continue to be in force until the first day of May, one thousand eight hundred and thirty-six, and no longer.

XIII. And be it further enacted by the authority aforesaid, that another certain Act passed in the second year of the Reign of His Majesty William, the Fourth, chapter twenty-six, intituled, "An Act to repeal certain Acts, therein mentioned, and for the further encouragement of Elementary Schools in the Country parts of this Province," which would otherwise expire on the fifteenth day of May next, shall continue to be in force, as amended

by the Act of the last Session of the Provincial Parliament, chapter four, until the first day of May, one thousand eight hundred and thirty-six, and no longer.

XIV. And be it further enacted by the authority aforesaid, that a certain other Act passed in the second year of the Reign of His Majesty William the Fourth, chapter thirty-two, intituled, "An Act to compel Wharfingers and others to advertize unclaimed goods in their possession," which would otherwise expire on the first day of May next, shall continue to be in force until the first day of May, one thousand eight hundred and thirty-six, and no longer.

XV. And be it further enacted by the authority aforesaid, that another certain Act passed in the second year of the Reign of His Majesty William the Fourth, chapter forty-two, intituled, "An Act to authorize the appointing of Courts of enquiry for investigating the qualification of Militia Officers in certain cases," which would otherwise expire on the first day of May next, shall continue to be in force until the first day of May, one thousand eight hundred and thirty-six, and no longer,

XVI. And be further enacted by the authority aforesaid, that the several Acts continued by this Act, or any of them, may be altered, amended or continued to any other period, or even repealed if need be, by any Act passed during the present Session of the Provincial Parliament.
