X. And be it further enacted and declared, that this Act shall continue and be in force until the first day of May, Eighteen hundred and thirty-eight, and no longer : Provided always, that the expiration of this Act shall not in any way affect or be construed to affect any convict who shall then have been delivered on board of any ship or vessel, to be conveyed to England as in this Act provided, or any matter or thing done or to be done in consequence of the delivery of such Convict as aforesaid; but this Act shall, with regard to such Convict, matter or thing be considered to be, and shall be in full force and effect until all the requirements and enactments thereof shall in that behalf have been fully complied with and accomplished.

An Act to grant an Allowance to the Members of the Assembly.

[18th November, 1835.]

MOST GRACIOUS SOVEREIGN.

Preamble.

Certain allowances granted to the Members of the Assembly for the Session begun on the 21st of February and ended on the 18th March, 1835, for the present and for the future Session or Sessions of the ment.

TATHEREAS it is expedient to make an allowance to the Members of the Assembly for their expenses occasioned by their attendance at the Sessions of the Provincial Parliament ;- May it therefore please Your Majesty that it may be enacted, and be it enacted by the King's Most Excellent Majestv, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, " intituled ' An Act for making more effectual provision for the Government of the " Province of Quebec, in North America,' and to make further provision for the " Government of the said Province ;" And it is hereby enacted by the authority of the same, that for the Session begun on the twenty-first day of February, one thousand eight hundred and thirty-five, and ended on the eighteenth day of March in the same year, for the present Session, and for the future Session or Sessions of the present Provincial Parliament, there shall be allowed and paid to each present Parlia- Member of the Assembly attending the said Session Ten Shillings currency for each day's attendance thereat, and Four Shillings currency for each league of the distance between the usual place of the residence of such Member and the place at which the Sessions of the Provincial Parliament are held.

The amount of the allowance to be advanced to the Clerk of the Assembly by Warrant of the Governor. II. And be it further enacted by the authority aforesaid, that for the purposes of this Act, a sum equal to the amount of the said allowance for the whole number of Members returned to serve in the Assembly, may be annually advanced to the Clerk of the Assembly, by Warrant, under the hand of the Governor, Lieutenant Governor, or person administering the Government of the Province for the time being, out of any unappropriated monies in the hands of the Receiver General in this Province, at any time after the opening of each such Session of the Provincial Parliament, and that the amount of the said allowance to which each Member shall be entitled for the then present, and also for any preceding Session, shall be paid to him by the said Clerk, upon an order to that effect made by the Assembly, on a statement by him submitted of the amount of allowance due to each Member, at the close of each Session of the present Provincial Parliament.

Application of the Monies advanced under this Act to be recommed for to 11 + Magaza III. And be it further enacted by the authority aforesaid, that the due application of the monies advanced pursuant to the directions of the present Act, shall be accounted for to His Majesty, His Heirs, and Successors, through the Lords Commissioners of His Majesty's Treasury for the time being, in such manner and form as His Majesty, His Heirs and Successors shall be pleased to direct.

AN Act for the more speedy relief of Insolvent Debtors in certain cases, and for a limited time.

[18th December, 1835.]

Preamble.

HEREAS it is expedient to afford a speedy relief to Insolvent Debtors by exempting them to a limited extent from arrest under Writs of Capias ad satisfaciendum :—Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal "certain parts of an Act passed in the fourteenth year of His Majesty's Reign, inti-"tuled, "An Act for making more effectual provision for the Government of the Province of Quebec, in North America," and to make further provision for the Govern-"ment of the said Province;" And it is hereby enacted by the authority of the same, that from and after the passing of this Act, any person who now is or shall be hereafter
