CAP. XIII.

An Ordinance to continue for a limited time, certain Acts of the Legislature of this Province, relative to the District of Saint Francis.

Preamble.

THEREAS it is expedient to continue for a limited time, the several Acts of the Legislature of this Province, hereinafter mentioned:—Be it there. fore Ordained and Enacted, by His Excellency the Administrator of the Government of this Province, authorized to execute the Commission of the Governor thereof, with the advice and consent of the Special Council for the affairs of the said Province. constituted and assembled by virtue of and under the authority of an Act passed by the Parliament of the United Kingdom of Great Britain and Ireland, in the First Year of the Reign of Her present Majesty, intituled, "An Act to make temporary pro-" vision for the Government of Lower Canada;" And it is hereby Ordained and Enacted by the authority of the same, that a certain Act of the Legislature of the said Province. made and passed in the third year of the Reign of His said late Majesty, King George the Fourth, intituled, "An Act to erect certain Townships therein mentioned into an " Inferior District, to be called the Inferior District of Saint Francis, and to estab-" lish Courts of Judicature therein;" and a certain other Act of the same Legislature, made and passed in the eleventh year of the Reign of His late Majesty, King George the Fourth, intituled,"An Act to continue further for a limited time. a " certain Act passed in the third year of His Majesty's Reign, intituled, 'An Act to " erect certain Townships therein mentioned into an Inferior District, to be called the " Inferior

"Inferior District of Saint Francis, and to establish Courts of Judicature therein," and " to make further provision for the due Administration of Justice in the said Infe-" rior District;" and a certain other Act, of the same Legislature, made and passed in the second year of the Reign of His late Majesty, King William the Fourth, intituled, "An Act to make better provisions with regard to Appeals from the Provin-" cial Court of the Inferior District of Saint Francis, to establish Circuits therein, " and to extend the benefits of Trial by Jury to the said Inferior District;" and also a certain other Act of the same Legislature, made and passed in the third year of the Reign of His late Majesty King William, the Fourth, intituled, "An Act "further to continue, for a limited time, and to amend a certain Act therein men-"tioned, relating to the Inferior District of Saint Francis," shall, with such amendments as may have been made to the same respectively, be held, taken and considered to have been, and to have continued to be, in full force and virtue, from the times of passing the same respectively, to the present time, and shall be, continue and remain in full force and virtue, until the first day of November, which will be in the year of Our Lord, one thousand eight hundred and forty-two.
