## An Act to continue for a limited time certain Acts therein mentioned. (21st March, 1836.)

Whereas it is expedient further to continue for a limited time the several Acts hereinafter mentioned; Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign intituled, 'An Act for making more effectual provision for the Government of the Province of Quebec, in North America;' And to make further provision for the Government of the said Province;" and it is hereby enacted by the authority of the same, that a certain Act passed in the seventh year of the Reign of His late Majesty George the Fourth, Chapter three, intituled, "An Act more effectually to provide for the maintenance of good order in Churches, Chapels, and other places of public worship and for other purposes therein mentioned," shall be, and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.

- II. And be it further enacted by the authority aforesaid, that a certain other Act passed in the ninth year of the Reign of the said late Majesty, Chapter sixteen, intituled, "An Act to encrease the number of assesors for the Cities of Quebec and Montreal", shall be, and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.
- III. And be it further enacted by the authority aforesaid, that a certain other Act passed in the ninth year of His said late Majesty's Reign. Chapter twenty, intituled, "An Act to provide for the more effectual extinction of secret incumbrances on lands than was heretofore in use in this Province," shall be, and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.
- IV. And be it further enacted by the authority aforesaid, that a certain other Act passed in the ninth year of His said late Majesty's Reign, Chapter twenty-seven, intituled, "An Act to prevent fraudulent Debtors evading their Creditors in certain parts of this Province," shall be, and the said Act is hereby continued and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.
- V. And be it further enacted by the authority aforesaid, that a certain other Act passed in the ninth year of His said late Majesty's Reign, Chapter twenty-eight, intituled, "An Act to

facilitate the proceedings against the estates and effects of Debtors in certain cases," shall be, and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.

VI. And be it further enacted by the authority aforesaid, that a certain other Act passed in the ninth year of His said late Majesty's Reign, Chapter fifty-one, intituled, "An Act for the preservation of the Salmon Fisheries in the Counties of Cornwallis and Northumberland," shall be and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.

VII. And be it further enacted by the authority aforesaid, that a certain other Act passed in the tenth and eleventh years of His said late Majesty's Reign. Chapter sixteen, intituled, "An Act to amend an Act passed in the the thirty-fourth year of the Reign of His late Majesty George the Third, intituled, 'An Act for the division of the Province of Lower Canada, to amend the Judicature thereof, and to repeal certain Laws therein mentioned, in as much as the same relates to the Courts of Criminal Jurisdiction," shall be, and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.

VIII. And be it further enacted by the authority aforesaid, that a certain other Act passed in the first year of His present Majesty's Reign, Chapter two, and intituled, "An Act to facilitate the administration of Justice respecting Enquetes in civil matters, before the Court of King's Bench for the Districts of Quebec, Montreal and Three Rivers [Trois-Rivières], and the Inferior District of Saint Francis [Saint-François]," shall be, and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.

- IX. And be it further enacted by the authority aforesaid, that a certain other Act passed in the first year of His present Majesty's Reign, Chapter six, intituled, "An Act to encourage the destruction of wolves," shall be, and the said Act is hereby continued and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.
- X. And be it further enacted by the authority aforesaid, that a certain other Act passed in the first year of His present Majesty's Reign, Chapter twenty-eight, intituled, "An Act to suspend certain parts of an Ordinance therein mentioned, intituled, 'An Ordinance for regulating the Markets of the Towns of Quebec and Montreal, in the Province of Quebec," shall be, and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.
- XI. And be it further enacted by the authority aforesaid, that a certain other Act passed in the second year of His Present Majesty's Reign, Chapter thirty-two, intituled, "An Act to compel Wharfingers and other to advertize unclaimed goods in their possession," shall be,

and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.

XII. And be it further enacted by the authority aforesaid, that a certain other Act passed in the second year of His present Majesty's Reign, Chapter thirty-three, intituled, "An Act to repeal a certain Act therein mentioned, and to provide for the more certain and expeditious distribution of the printed Acts of the Legislature of this Province," shall be and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.

XIII. And be it further enacted by the authority aforesaid, that a certain other Act passed in the third year of His present Majesty's Reign, Chapter thirty-one, intituled, "An Act to repeal a certain Act therein mentioned and to provide more effectually for the remedy of divers abuses prejudicial to Agriculture," shall be, and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.

XIV. And be it further enacted by the authority aforesaid, that a certain other Act passed in the fourth year of His Majesty's Reign, Chapter twenty-five, intituled, "An Act to make provision for indemnifying Pilots, while detained in quarantine," shall be, and the said Act is hereby continued, and shall remain in force until the first day of May, one thousand eight hundred and forty, and no longer.

XV. And be it further enacted by the authority aforesaid, that nothing in this Act contained, shall extend, or be construed to extend to prevent the amendment or repeal of the said Acts hereby continued, or of any of them, by any other Act passed during the present Session of the Provincial Legislature.
