whom such sums shall be respectively advanced, or under whose superintendence they shall be expended, may be advanced to and expended by such persons or officers, and under such instructions and regulations as the Governor, Lieutenant Governor, or person administering the Government of this Province for the time being, shall think fit to appoint, issue and make.

VII. And be it further Ordained and Enacted by the authority aforesaid, that each and every the persons, societies, and officers respectively, to whom the expenditure of any portion of the monies hereby appropriated shall be entrusted, shall make up and transmit to the Governor, Lieutenant Governor, or person administering the Government of this Province for the time being, detailed reports of their proceedings in that behalf, at any time or times when he shall think it expedient to require or demand any such report.

VIII. And be it further Ordained and Enacted by the authority aforesaid, that each and every person to whom shall be entrusted the expenditure of any portion of the public monies hereby appropriated, or authorised to be expended, shall make up detailed accounts of such expenditure, shewing the sum advanced to the Accountant, the sum actually expended, the balance (if any) remaining in his hands, and the amount of the monies hereby appropriated to the purpose for which such advance shall have been made, remaining unexpended in the hands of the Receiver General; and each and every such account shall be supported by vouchers therein distinctly referred to by numbers corresponding to the numbering of the items of such account, and shall be made up to and closed on the tenth day of April, and the tenth day of October, in each and every year during which such expenditure shall be made, and shall be attested before a Justice of the Court of King's Bench, or a Justice of the Peace, and shall be transmitted to the officer whose duty it shall be to receive the same, within fifteen days after the said periods respectively.
