

missioners of the Treasury, in such manner and form as Her Majesty, her heirs or successors may be pleased to direct; and an account of such expenditure shall be laid before the Provincial Legislature during the then next Session thereof.

Not to be in force until the Royal assent is notified.

V. And be it further Ordained and Enacted by the authority aforesaid, that this Ordinance shall not be in force until it shall have been laid before Her Majesty, in Her Privy Council, nor until Her Majesty's assent thereto shall have been proclaimed in this Province.

C A P. XXIII.

An Ordinance to repeal a certain Act therein mentioned, relative to a certain Market Place at Près de Ville, in the City of Montreal.

Preamble.

WHEREAS François Antoine La Rocque, Jules Maurice Quesnel, and Alexis Laframboise have, by their petition to His Excellency the Governor in Chief, prayed that the Act hereinafter mentioned should be repealed, and that the Market Place, and buildings therein mentioned, should be again vested in and belong to the said Petitioners as if the said Act had never been passed; and whereas the

the Justices of the Peace residing in the City of Montreal, did, at a Special Session duly called for the purpose of considering the object of the said Petition, and held on the twelfth day of March, one thousand eight hundred and thirty-nine, resolve, that the interests of the said City would not suffer from the prayer of the said Petition being granted, provided the said Petitioners should have no claim to any balance of interest due on the estimated value of the said Market Place and buildings, and the said Resolution was duly certified to His Excellency the Governor in Chief, by the order of the said Justices; and whereas it is expedient that the prayer of the said Petitioners should be granted, subject to the provision aforesaid:—Be it therefore Ordained and Enacted by His Excellency the Governor of the Province of Lower Canada, by and with the advice and consent of the Special Council for the affairs of the said Province, constituted and assembled by virtue of, and under the authority of an Act of the Parliament of the United Kingdom of Great Britain and Ireland, passed in the first year of the Reign of Her present Majesty, intituled, “*An Act to make temporary provision for the Government of Lower Canada,*” And it is hereby Ordained and Enacted by the authority of the same, that the Act passed in the ninth year of the Reign of King George the Fourth, chapter thirty-nine, intituled, “*An Act to establish a certain Market Place in the City of Montreal,*” shall be and is hereby repealed, and the property of the Market Place, and of the buildings thereon erected, described in the said Act, shall be and is hereby vested in the said François Antoine La Roche, Jules Maurice Quesnel, and Alexis Laframboise, and their legal representatives, as if the said Act had never been passed: Provided always, that neither they, nor any of them, shall have any claim whatever, on any person, property, or fund, public or private, for any balance of interest due at the time of the passing of this Ordinance, on the sum ascertained under the provisions of the said Act, as the value of the said Market Place and buildings; And provided also, that nothing in this Ordinance shall extend to give the said François Antoine La Roche, Jules Maurice Quesnel, Alexis Laframboise, or any, or either of them, or their legal representatives, any greater or better title or interest to or in the property aforesaid, than they would have had, if the said Act had never been passed, or to affect or weaken any claim, right, or interest, which any other person, body politic or corporate, would, in that case, have had.

C A P. XXXIV.

An Ordinance to provide for the improvement, during the winter season, of the principal Post Roads from various parts of the Province to Montreal, and for other purposes.

Preamble.

WHEREAS it is expedient to provide for the improvement of the principal Post Roads, from various parts of the Province to Montreal, during the Winter Season, and for the introduction of more suitable Vehicles of conveyance on the Winter Roads:—Be it therefore Ordained and Enacted by His Excellency the Governor of the Province of Lower Canada, by and with the advice and consent of the Special Council for the affairs of the said Province, constituted and assembled by virtue of and under the authority of an Act of the Parliament of the United Kingdom of Great Britain and Ireland, passed in the first year of the Reign of Her present Majesty, intituled, "*An Act to make temporary provision for the Government of Lower Canada;*"—And it is hereby Ordained and Enacted by the authority of the same, that after the first day of October next after the passing of this Ordinance, no Winter Carriage, or Vehicle without wheels, shall be used for the conveyance of any other load than passengers and their baggage, (to the amount of one hundred weight for each passenger,) on the principal Post Road from Hull, in the County of Ottawa, from *Pointe à Baudet* and *Coteau du Lac*, from Dundee, in the County of Beauharnois, from Phillipsburg, in the County of Missisquoi, and from Sherbrooke, to and from the City of Montreal, except Sleighs, having runners, at least six Eng-
