CAP. IV.

An Ordinance to render permanent certain Acts therein mentioned, relating to the administration of Justice in the Inferior District of Gaspé.

THEREAS it is expedient to render permanent the several Acts of the Pro-

vincial Legislature hereinafter mentioned .---Be it therefore Ordained and Enacted by His Excellency the Governor of this Province of Lower Canada, by and with the advice and consent of the Special Council for the affairs of this Province, constituted and assembled by virtue and under the authority of an Act of the Parliament of the United Kingdom of Great Britain and Ireland, passed in the first year of the Reign of Her present Majesty, intituled. " An Act to make temporary " provision for the Government of Lower Canada," and also by virtue and under the authority of a certain other Act of the same Parliament, passed in the Session held in the second and third years of the Reign of Her present Majesty, intituled, " An Act to amend an Act of the last Session of Parliament, for making temporary " provision for the Government of Lower Canada;" And it is hereby Ordained and Enacted by the authority of the said Acts of Parliament, that a certain Act passed Act2, Geo. 1V. in the second year of the Reign of His Majesty King George the Fourth, chapter five, intituled, "An Act to extend the provisions of a certain Act therein mention-· cd, as far as the same relates to the Judicature of the Inferior District of Gaspé, " and more effectually to provide for the due administration of Justice in the said Dis-" trict," as amended by the Acts therein mentioned, and a certain other Act passed in 4 Geo. IV. c. the fourth year of the Reign of His said Majesty, chapter seven, intituled, "An Act to amend a certain Act therein mentioned, and further to extend the jurisdiction of " the Provincial Court for the Inferior District of Gaspé," as amended by the Acts hereinafter mentioned, and a certain other Act passed in the sixth year of the Reign of His said Majesty, chapter twenty-five, intituled, "An Act to amend and conti-" nue for a limited time, two certain Acts therein mentioned, relating to the Judi-" cature in the Inferior District of Gaspé," as amended by the Act hereinafter mentioned, and a certain other Act passed in the second year of the Reign of His late Majesty King William the Fourth, intituled, "An Act to continue and amend " certain Acts relating to the Judicature of the Inferior District of Gaspé," which said Acts have since been continued in force by other Acts of the Provincial Legislature, and by an Ordinance of the Governor of this Province and of the Special Council for the affairs thereof, passed in the second year of Her Majesty's Reign, chapter twenty, until the first day of November, one thousand eight hundred and forty-two, when they would otherwise expire, shall be, and the said Acts so amended as aforesaid.

CAP.V.

An Ordinance to provide permanently for the want of Notaries in the Inferior District of Gaspé, and to remove doubts therein mentioned.

HEREAS in and by the tenth Section of a certain Act made and passed in the fourth year of the Reign of His Majesty King George the Fourth, intituled, "An Act to render valid certain Acts, agreements in writing, and Contracts of Marriage, Contrats de Mariage sous seing privé, heretofore executed in the In-"ferior District of Gaspé, and to provide for the want of Notaries in the said Infe. "rior District," it is enacted that certain Deeds and Acts, and legal Instruments and Documents in writing therein specified, shall if executed in the said Inferior District, within the period and in the manner provided by the said Section, and if all the provisions and requirements thereof be complied with, in regard to the same, have the same effect in certain respects therein mentioned as if the same had been executed before Notaries, and whereas the period so fixed by the said Act was intended
