An Ordinance to appropriate certain sums of money to the support of certain Charitable Institutions.

Preamble.

WHEREAS it is expedient to appropriate the sums of money hereinafter mentioned for the purposes and towards the support of the several Charitable Institutions, also hereinafter mentioned:—Be it therefore Ordained and Enacted by His

His Excellency the Governor of the Province of Lower Canada, by and with the advice and consent of the Special Council for the affairs of the said Province, constituted and assembled by virtue of and under the authority of an Act of the Parliament of the United Kingdom of Great Britain and Ireland, passed in the first year of the Reign of Her present Majesty, intituled, "*An Act to make temporary provision for the Government of Lower Canada*;" and it is hereby Ordained and Enacted by the authority of the same, that it shall be lawful for the Governor, Lieutenant Governor, or person administering the Government, to advance and pay, from time to time, during the present year, by warrant under his hand, and out of any unappropriated monies which may then be in the hands of the Receiver General, the following sums for the purposes and to the persons hereinafter set forth, that is to say :

II. And be it further Ordained and Enacted by the authority aforesaid, that the said several sums may be advanced to the Commissioners under whose superintendance the said Institutions may respectively be at the time of the passing of this Ordinance : Provided always, that it shall be lawful for the Governor, Lieutenant Governor, or person administering the Government to remove the said Commissioners, or any of them, and to appoint others in their stead, if he shall deem it expedient so to do.

III. And be it further Ordained and Enacted by the authority aforesaid, that every person to whom shall be entrusted the expenditure of any portion of the monies hereby appropriated, shall make up detailed accounts of such expenditure, shewing the sums advanced to the Accountant, the sum actually expended, the balance, if any, remaining in his hands, and the amount of the monies hereby appropriated to the purpose for which such advance shall have been made, remaining unexpended in the hands of the Receiver General ; and that every such account shall be supported by Vouchers, therein distinctly referred to by numbers corresponding to the numbering of the items in such account, and shall be made up to, and closed on the tenth day of April, and tenth day of October in each year, in which such expenditure shall be made, and shall be attested before a Justice of the Court of King's Bench, or a Justice of the Peace, and shall be transmitted to the officer whose duty it shall be to receive such accounts, within fifteen days next after the expiration of the said periods respectively.

IV. And be it further Ordained and Enacted by the authority aforesaid, that the due application of the monies appropriated by this Ordinance shall be accounted for to Her Majesty, her heirs and successors, through the Lords Commissioners of Her Majesty's Treasury, in such manner and form as Her Majesty, her heirs and successors, shall direct.

An Ordinance to appropriate certain Sums therein mentioned to the encouragement of Education.

Preamble.

WHEREAS it is expedient to appropriate certain sums of money for the encouragement of Education in this Province:—Be it therefore Ordained and Enacted by His Excellency the Governor of the Province of Lower Canada, by and with the advice and consent of the Special Council for the affairs of the said Province, constituted and assembled by virtue of and under the authority of an Act of the Parliament of the United Kingdom of Great Britain and Ireland, passed in the first year of the Reign of Her present Majesty, intituled, "*An Act to make temporary provision for the Government of Lower Canada;*" And it is hereby Ordained and Enacted by the authority of the same, that it shall be lawful for the Governor, Lieutenant Governor, or person administering the Government of this Province, by Warrants under his hand, to authorize the payment of the sums hereinafter mentioned, out of any unappropriated monies that may be in the hands of the Receiver General, that is to say :
