An Ordinance to revive and continue certain Acts of the Legislature of this Province therein-mentioned.

Preamble.

**W**HEREAS a certain Act of the Legislature of this Province, passed in the fifty-seventh year of the Reign of His late Majesty King George the Third, intituled, "An Act to provide temporary Houses of Correction in the several Districts of this Province," and also a certain other Act of the said Legislature, passed in the fifty-eighth year of the Reign of His said late Majesty King George the Third, intituled, "An Act to amend an Act passed in the fifty-seventh year of His Majesty's Reign, intituled, "An Act to provide temporary Houses of Correction in the several Districts of this Province, and for other purposes," and also a certain other Act of the said Legislature, passed in the third year of the Reign of His late Majesty King George the Fourth, intituled, "An Act further to continue for a limited time, two certain Acts therein mentioned, relating to the Houses of Correction in the several Districts of this Province," and also a certain other Act of the said Legislature, passed in the fifth year of the Reign of His said late Majesty King George the Fourth, intituled, "An Act still further to continue for a limited time, certain Acts therein mentioned, relating to the Houses of Correction in the several Districts of this Province," and also a certain other Act of the Legislature of this Province, passed in the ninth year of the Reign of his said late Majesty King George the Fourth, intituled, "An Act to revive and further to continue for a limited time, and to amend a certain Act passed in the fifth year of His Majesty's Reign, relating to Houses of Correction in the several Districts of this Province," have expired; And whereas it is expedient to revive and to continue for a limited time, the said several Acts of the said Legislature :—Be it therefore Ordained

dained and Enacted by His Excellency the Governor of the Province of Lower Canada, by and with the advice and consent of the Special Council for the affairs of the said Province, constituted and assembled by virtue of and under the authority of an Act of the Parliament of the United Kingdom of Great Britain and Ireland, passed in the first year of the Reign of Her present Majesty, intituled, "*An Act to make temporary provision for the Government of Lower Canada;*"—And it is hereby Ordained and Enacted by the authority of the same, that all and every the said Acts of the said Legislature be, and the same are hereby revived, and that the same be, and they are hereby continued in force until the expiration of this Ordinance, and no longer.

II. And be it further Ordained and Enacted by the authority aforesaid, that this Ordinance shall be and remain in force, until the first day of November, one thousand eight hundred and forty two, and no longer.
