CAP. LIII.

An Ordinance to provide for the completion of certain Public Works, for the improvement of the Internal Communications, and for the encouragement of Agriculture, and for other purposes.

Preamble.

THEREAS it is expedient to provide for the Internal Communications of the Province, and for the completion or performance of certain Public Buildings and Works therein, and for other objects connected with the general improvement of the Province :- Be it therefore Ordained and Enacted by His Excellency the Governor of the Province of Lower Canada, by and with the advice and consent of the Special Council for the affairs of the said Province, constituted and assembled by virtue of, and under the authority of an Act of the Parliament of the United Kingdom of Great Britain and Ireland, passed in the first year of the Reign of Her present Majesty, intituled, " An Act to make temporary provision for the "Government of Lower Canada;"-And it is hereby Ordained and Enacted by the authority of the same, that it shall be lawful for the Governor, Lieutenant Governor, or Person administering the Government of this Province, by warrant under his hand, and out of any unappropriated monies which may be in the hands of the Receiver General, to advance and pay the several sums hereinafter mentioned. for the purposes also hereinafter mentioned and specified, respectively, that is to sav:

By whom the monies are to be expended. II. And be it further Ordained and Enacted by the authority aforesaid, that the several sums hereby appropriated with regard to which no provision is made by this Ordinance, or by any other Act or Ordinance as to the persons or officers to whom such sums respectively shall be advanced, or under whose superintendence they shall be expended, may be advanced to and expended by such persons or officers, and under such instructions and regulations as the Governor, Lieutenant Governor, or person administering the Government, shall think fit to appoint, issue, and make.

No portion of the monies to be expended without the sanction of the Governor. III. Provided always, and be it further Ordained and Enacted by the authority aforesaid, that no portion of any of the sums hereby appropriated, except such as are appropriated to reimburse or make good expenses already incurred and approved as hereinafter mentioned, shall be expended by the persons or officers to whom they shall be respectively advanced, until after the mode and plan, according to which it shall be proposed to expend them shall have been submitted to and approved by the Governor, Lieutenant Governor, or person administering the Government, nor until it shall appear to his satisfaction, that sufficient security has been given for the due performance of the work (if such work is to be performed by contract,) for the sum appropriated for the same, and within a time certain, fit and consistent with the public good.

Detailed reports of proceedings to be

transmitted to

the Governor.

IV. And be it further Ordained and Enacted by the authority aforesaid, that each and every the persons, societies and officers respectively, to whom the expenditure of any portion of the monies hereby appropriated shall be entrusted; shall make up and transmit to the Governor, Lieutenant Governor, or person administering the Government, detailed reports of their proceedings in that behalf, at any time or times when he shall think it expedient to require and demand any such report.

Detailed accounts to be rendered. V. And be it further Ordained and Enacted by the authority aforesaid, that every person to whom shall be entrusted the expenditure of any portion of the monies hereby appropriated, shall make up detailed accounts of such expenditure, shewing the sum advanced to the Accountant, the sum actually expended, the balance, if any, remaining in his hands, and the amount of the monies hereby appropriated to the purpose for which such advance shall have been made, remaining unexpended in the hands of the Receiver General; and every such account shall be supported by Vouchers, therein distinctly referred to by numbers corresponding with the numbering of the items in such account, and shall be made up to, and closed on the tenth day of April, and the tenth day of October in each year, during which such expenditure shall be made, and shall be attested before a Justice of the Court of King's Bench, or a Justice of the Peace, and such accounts, shall be transmitted to the officerwhose duty it shall be to receive the same, within fifteen days after the said periods respectively.

Application of the monies to be accounted for. VI. And be it further Ordained and Enacted by the authority aforesaid, that the due application of the monies hereby appropriated, shall be accounted for to Her Majesty, her heirs and successors, through the Lords Commissioners of Her Majesty's Treasury, in such manner and form as Her Majesty, her heirs and successors, shall direct.

CAP. LIV.

An Ordinance to continue for a limited time, the " Act to create a fund for " defraying the expense of Medical Assistance for Sick Emigrants, and " of enabling Indigent Persons of that description to proceed to their " place of destination."

Preamble.

HEREAS it is expedient to continue, for a limited time, the Act hereinafter mentioned .- Be it therefore Ordained and Enacted by His Excellency the Governor of the Province of Lower Canada, by and with the advice and consent of the Special Council for the affairs of the said Province, constituted and assembled by virtue of, and under the authority of an Act of the Parliament of the United Kingdom of Great Britain and Ireland, passed in the first year of the Reign of Her present Majesty, intituled, " An Act to make temporary provision for the Government of Lower Canada;" And it is hereby Ordained and Enacted by the authority of the same, that a certain Act made and passed in the second year of the Reign of His late Majesty, chapter seventeen, intituled, " An Act to create a fund for defraying "the expense of Medical assistance for Sick Emigrants, and of enabling indigent Act 2d Will. " persons of that description to proceed to their place of destination," shall be, and 1V. Cap. 17 persons of that description to proceed to their place of destination, shall be, and continued till is hereby continued, and shall remain in force, until the first day of November in 1st Nov. 1839. the present year, one thousand eight hundred and thirty-nine, and no longer.
