An Ordinance to continue for a limited time, the " Act to create a fund for defraying the expense of Medical Assistance for Sick Emigrants, and of enabling Indigent Persons of that description to proceed to their place of destination."

Preamble.

WHEREAS it is expedient to continue, for a limited time, the Act hereinafter mentioned:—Be it therefore Ordained and Enacted by His Excellency the Governor of the Province of Lower Canada, by and with the advice and consent of the Special Council for the affairs of the said Province, constituted and assembled by virtue of, and under the authority of an Act of the Parliament of the United Kingdom of Great Britain and Ireland, passed in the first year of the Reign of Her present Majesty, intituled, "*An Act to make temporary provision for the Government of Lower Canada;*" And it is hereby Ordained and Enacted by the authority of the same, that a certain Act made and passed in the second year of the Reign of His late Majesty, chapter seventeen, intituled, "An Act to create a fund for defraying the expense of Medical assistance for Sick Emigrants, and of enabling indigent persons of that description to proceed to their place of destination," shall be, and is hereby continued, and shall remain in force, until the first day of November in the present year, one thousand eight hundred and thirty-nine, and no longer.

An Ordinance to extend the provisions of the Ordinance for establishing an efficient system of Police in the Cities of Quebec and Montreal.

Preamble.

WHEREAS it is expedient to extend the provisions of the Ordinance hereinafter cited, to the Town and Borough of Three Rivers :— Be it therefore Ordained and Enacted by His Excellency the Governor of the Province of Lower Canada, by and with the advice and consent of the Special Council for the affairs of the said Province, constituted and assembled by virtue of and under the authority of an Act of the Parliament of the United Kingdom of Great Britain and Ireland, passed in the first year of the Reign of Her present Majesty, intituled, “ *An Act to make temporary provision for the Government of Lower Canada* ;” and it is hereby Ordained and Enacted by the authority of the same, that the Ordinance made and passed in the second year of Her Majesty's Reign, chapter two, intituled, “ An Ordinance for establishing an efficient system of Police in the Cities of Quebec and Montreal,” shall be, and is hereby extended to the Town and Borough of Three Rivers, together with such neighbouring District as the Governor, or person administering the Government shall, at any time direct ; and the Governor, or person administering the Government of this Province shall, with regard to the said Town and Borough and such neighbouring District as aforesaid, have all the powers and authority vested in him by
