An A& for the Choice of Town Officers and Regulating of Townships.

Whereas the method of nominating the ref- Cap 1 pective Town Officers herein after mentioned by the Grand Jurors for the feveral Counties, as directed by the Laws of this Province, is found inconvenient.

Alfembly, That the Governor, Counsil, and Alfembly, That the Grand Juries for the BOS feveral Counties in this Province, at the Court of General Seffiens of the Peace for Publication of this Act, and hereafter annually

at the First Sessions of the faid Court, shall nominate out of every Township in the faid County, Ten fit Persons, out

of whom the faid Court shall appoint five to be Surveyors of Lines and Bounds of each Respective Township, which are hereby impowered to furvey, examine, and alcertain the Lines and Bounds of their faid refpective Townships, agreeable to the feveral Grants thereof; and who shall alfo be Overfeers of the poor of faid Township, and at the same Time the faid Grand Jury shall in like manner nominate "two Perfons, one of whom the Court fhall appoint to le Town Clerk of the faid Town, who shall be Iwora truly to enter, and Record all fuch Matters and Things, as shall relate to the fail Township, and shall appertuin to his Office; and shall also nominate four or more Constables. of whom the Court thall ap, oint two or more as they fhat! sce convenient to be Conflables in the faid Township; and alto shall nominate Four Surveyors of Highways, of whom the faid Court shall appoint two to be Surveyors of Highways in the faid Township; and shall also nominate Fur Fence Viewers of whom the faid Court shall appoint two to . be Fence Viewers in the faid Township, and thall also nominate Two Clerks of the Market of whom the fud Cours Thall appoint one to be Clerk of the Market in faid Town-" thip ; and thall also nominate Four Pound Keepers of whom the laid Court shall appoint a sufficient Number in their Diferction to be Pound Keepers in the faid Township; and shall also nominate Four or more Cullers and Surveyors of Filb of whom the faid Court shall appoint a sufficient number in their Diferction to be Gullers and Surveyors of Fifb in the faid Townthip; and Ihall allo nominate Four Surveyors of Lumber and Cord Wood, ot whom the faid Court shall appoint two to be Surveyors of Lumber and Cord-Wood in the faid Township; and shall also nominate Two Sealers of Leather, of whom the faid Court shall appoint one to be Sealer of Leather in the faid Township; and shall alfo nominate Four Gaugers of Cafks, of whom the faid Court shall appoint ento to be Gaugers of Cafes in the faid Township; and shall also nominate Four Hegreques, of whom the faid Court shall appoint two to be Hogreaves in the feid Township; who shall respectively be form to the Saithful discharge of their Duty in manner as is already pre-Ecribed, by the Laws of this Province, and thall in every relpeat

respect conform to the faid Laws, and upon their, or any of their Refusal to accept, or being guilty of any Neglect, or Milsbehavjour in the Execution of the Duty of their respective officers they thall forfeit and pay for the Ule of the Poor of the faid Townthip, the Sum of Fonty Shillings for every fuch Refufal, Regicet or Missbehaviour, to be recover'd upon proof of filen Refutal, Neglect or Milsbehaviourby the oath if one Cledible Winefs before any Two of his Majefty's Juffnes of the Reace, for the County, wherein fuch Townihip lies, to be sevied by Warrant of Diffress, and Sale of the Officiers Goods and Chattles, any Law, Uluage, or Cultom to the contrary notwithstanding, and if any Perlon fo nominated and choien, thall leav the Province, change the Town of his Refidence, or happen to die within the Period, for which he was nominated and appointed to ferve in any of the faid Offices in fuch Cafe, any Two of his Majefv's Fuffices of the Peace for the County, Ihall and may nominate and appoint a fit Perfon or Perfons, to ferve in fuch Vacant office, until another shall be nominated by the Grand Jury, and appointed by the faid. Gourt of General Seffins, at their meeting next enfuing fuch Vacancy.

Provided always, that Nothing in this Act contained thall Extend, or be confirmed to Extend to refirain any privileges, that may bereafter be granted by any Charter of Incorporation to any Town br, Powns within this Province,

the state better Regulating the several Townships in this Province.

Be it : enacted. That the original Boundary Lines of each and every Township or District within, this Province, shall be run betwixt Township and Township, and marks renewed once in Ibree Years, viz. on the First Monday in March by the Surveyors of Lines and Bounds appointed for the respective Townships, as directed by this Act or the Major part of them, and the Persons so appointed for each respective Township are hereby impower'd and directed to give Six Days notice to the Persons appointed for the adjacent Townships,

of the Time and Place of Meeting for fuch Survey, and any Perfon or Perions appointed as aforefaid, refuting or neglecting to attend at the Place mentioned in fuch Notice, being duly ferved there with thall torfeit and pay the Sum of Forty Sbillings, each to be recover'd on Complaint before any two of his Majefly's Juffices for the County, where fuch Complaint thall be made, and one half of the faid Forfeiture, thall be paid to the Perfon or Ferfons, who thall Complain and protecute for the fame, and the other half to the Overfeers of the Poor for the ute of the Poor of fuch Towns, from whence the Complaint was made, and whenever the Surveyors of any Township, which thall have had Notice as aforefaid, thall refuse or neglect to attend the faid Bufinefs, the Surveyors who thall have given fuch notice thall, and they are hereby impower'd to proceed in running and marking fuch line, which thall be as affectuall as if the Surveyors of both Townships had join'd.

And be it further enacted, That each and every Proprieof Lands laying unfenced, or in any Common Field, shall once in Two. Years on Six Days notice given him, his Agent, or Attorney by the rext Proprietor or Proprietors adjoining, run the lines make and keep up the Boundaries of such Lands or Common Field by stones or other sufficient marks, and every party to neglecting or refuting, thall forfeit the Sum of Twenty Shillings, one half of which shall be to the party complaining, and the other half to the Overfeers of the poor for the Ute of the Poor of faid Township, and to be heard and determined before any one of his Majelty's Justices of the Peace within the fame County, and the Proprietors of any Field held in Common, whether divided or undiwided thall, and they are hereby impower'd to order, improve and fence in such way or manner, as shall be Concluded and agreed upon by the major part of the interested therein, the Voices to be collected and accounted according to their Respective interests, and if any perfor shall \* refule to make, keep up, support, and maintain his Quote part or Proportion of fuch Fence to agreed on to be made, and thall on notice given him for that Purpole by any one of the Proprietors concern'd with him in the faid common Field, neglect the fame for the space of Thirty Days, the Fence Fiewer. Ihall on Application being made to him, make and for up the deficient Fence, or repair any Fence already made, if in his judga trent the fame is infufficient, and the Perfon or Perfone, that of Right ought

ought to build and maintain the fame, fhall pay couble the Cofts and Charges expended for the doing thereof, and in cale of Refufal, such Fence Viewers may recover the same before the Inferior Court of Common Pleas or before one or two Julliers according to the value thereof; and the faid Fonce Viewars, shall be allowed three Shillings per Day for his own trouble, and Time expended therein.

And if any Perfon or Perfon, thall neglect or refufe to comply with any Regulations made by the Proprietors of any common Field as aforefaid, which Regulation thall be made annually, he or they thall forfeit and pay the Sum of *Ten Stillings* for the ufe of the Poor of the Town where tuch common Field thall lie, to be Recover'd by the oath of one Crehble Witnets before any one of his Majefty's Juffices of the Perce, for the County wherein fuch Lands are, to be levied by diftrets and tale of the Offenders Goods and Chattles, and thall moreover make Satisfaction for all damages, that may have arifen by fuch Neglect or refutal.

And whereas many inconveniencies have arifen for want of Cattle being branded or otherways mark'd, that run in Common.

Be it enacted, That all and every owner of any horfe or horfes, neat Cattle, Sheep or Swine; shall brand or otherways mark fuch horfe or horfes, neat Cattle, Sheep or Swine, in fuch manner as that the fame may be clearly known, and shall enter such mark for brand with the Town Clerk in a Book to be kept by him for that purpole, and the faid Town Clerk shall receive for Recording the faid mark or brand the Sum of Six Pence.
