Be it Enacted, by the Governor, Council, and Affembly, That the faid Supreme Court fhall be held for the Spring Circuit of the Year, One Thoufand Seven Hundred and Seventy Six, at King's County on the Firt Tuefday of May, at Annapolis on the Second Tuefday of May, at Cumberland on the laft Tuefday of May, and that all Writs and other Procefs returnable at faid Court, in each of the faid Counties, be made returnable accordingly.
