Chattels fufficient to fatisfy fuch Execution with Cofts, fuch Juf-tice or Juffices shall and may commit fuch Debtor to Goal until Goods and Chattels &c. for want therefuch Debt is discharged, or he be released by the Creditor, any of to be committed. Law, Ufage or Cuftom to the contrary notwithstanding.

And Whereas many Inconveniences arife by the Restriction contain'd in the Seventh Section of the faid afore recited Act.

III. Be it Enacted, That in all fuch Caufes brought as aforfaid, before the faid Juffice or Juffices, Cofts shall be awarded, as is directed by the Sixth Section of the afore recited Act, any Law, Juffices, Cofts phe Usage or Custom to the contrary netwithstanding.

In all caufes bro't before one 'or more awarded.

C A P. III.

An ACT to empower the Governor, Lieutenant Governor or Commander in Chief for the Time being to prohibit the Exportation of Gunpowder, Arms and Ammunition or Salt Petre or carrying the fame coaftways.

XXXXXX HEREAS it is thought necessiary, during the present Disturbances in AMERICA, and may beeaster be W A deemed expedient, to prevent the Exportation of Preamble, Gunpowder, Arms and Ammunition or Salt Petre or XSXXXX carrying the same coastways, except for his Majesty's Use and Service.

I. Be it therefore Enacted, by the Governor, Council and Af-Jembly, That it shall and may be lawful for the Governor, Lieutenant Governor, or Commander in Chief for the Time being, by and with the Advice and Confent of his Majefty's Council to iffue a Proclamation for prohibiting for fuch Time as shall be therein expressed ; the Exportation out of the Province or coast- the Governor. ways, any Gunpowder, Arms and Ammunition, or Salt Petre; except for his Majesty's Use and Service, or with Licence first obtained by the Governor, Lieutenant Governor, or Commander in Chief for the Time being, or other Perfon appointed by Government for that Purpofe.

II. And be it Enacted, That if any Gunpowder, Arms and Gonpowder, &c. Ammunition, or Salt Petre, shall be shipped or laden on board fuch Proclamation any Veffel for Exportation, or be carried coaftways, contrary to to be forfeited and the Data in the internet for mechibilities the Exponentian the Mafter of the fuch Proclamation fo iffued for prohibiting the Exportation Veffel to pay sel. thereof

The Governor, to iffue Proclamation for prohibiting for a time the exportation of Gunpowder, &c. except for his Majeky's use or with license from

thereof, the fame shall be forfeited, and the Master of such Veffel or any other Person or Persons concerned in shipping or lading any Gunpowder, Arms, and Ammunition, or Salt Petre; shall forfeit and pay the Sum of Fisty Pounds to be recovered in any of his Majesty's Courts of Record in this Province, and applied one half to his Majesty's Use, and the other half to the Informer.

Not to extend to prevent fmall Quantity of Gunpowder or Arms for Veffels ufe.

Aft to be in Force for 1 Year, and to to end of Seffion next following. *Provided*, That nothing in this Act shall extend or be confirued to extend to any small quantity of Gunpowder or small Arms for the Ship or Vessels Use.

And be it Enacted, That this Act shall continue for one Year from and after the Publication thereof, and until the end of the Session of the General Assembly then next following.
