**B**E *it enacted by the Lieutenant-Governor, Council and Assembly*, That an Act, passed in the last Session of the General Assembly, entitled, An Act to provide for the greater security of this Province, by a better regulation of the Militia, and to repeal the Militia Laws now in force, with every matter, clause and thing, therein contained, be continued, and the same is hereby continued for one year, and from thence to the end of the next Session of the General Assembly.

CAP. XVI.

An ACT to extend an Act, passed in the forty-first year of His late Majesty's Reign, entitled, An Act for the repairing, keeping in repair, cleansing and paving, the Streets in the Town and Peninsula of Halifax, to the Town of Windsor.

**B**E *it enacted by the Lieutenant-Governor, Council and Assembly*, That the Act, passed in the forty-first year of His late Majesty's reign, entitled, An Act for repairing, cleansing and

and paving, the Streets in the Town and Peninsula of Halifax, and for removing obstructions therein, and every matter, clause and thing, therein contained, save and except the first and tenth clauses thereof, be extended, and the same are hereby extended, to the Town of Windsor.

II. *And be it further enacted*, That it shall and may be lawful for the Lieutenant Governor, by and with the advice of His Majesty's Council, to nominate and appoint three fit and proper persons, Inhabitants of the Town of Windsor, to be Commissioners for the repairing, paving, and keeping in repair, the Streets and Lanes of the said Town, and for ascertaining and removing obstructions therein; and, in case of the death, removal or refusal, of any of the Commissioners so appointed, his or their places, from time to time, to be filled up by such person or persons, being Inhabitants of the said Town, and respectable Freeholders there, as the Governor, Lieutenant-Governor or Commander in Chief, for the time being, with the advice of His Majesty's Council, shall nominate and appoint.

III. *And be it further enacted*, That the limits of the said Town, subject to the controul and superintendance of the Commissioners, so to be appointed as aforesaid, shall extend from the Island, called Smith's Island, to the Northward and Eastward as far as the Bridge over the Trecothic Creek, on the main road leading out of the Town of Windsor as far as the Church; and on the Southward and Westward to the Falmouth Ferry.
