## CAP. VII.

An ACT authorifing the Lending a Sum of Money to the Governors of Dalhousie College, and for securing the re-payment thereof.

THEREAS a large sum of Money hath been expended in erecting the Dalhousie College, and Presubte which is now nearly completed, but debts incurred in its erection cannot be discharged without disposing of part of the Monies placed in the English Funds for the support of Professorships, the doing which would entirely prevent the Governors of the said College from proceeding only further towards: the accomplishment of the objects for which the said Building was erected and endowed. And whereas it would be injudicious, after the expenditure of large sums of Money upon the said Building, that the fur-- ther progress of the Governors should be delayed, without a fair trial being made of the usefulness of the said Institution; therefore, in order to enable the Governors of the said College to discharge the said debt :

1. BE it enacted by the Lieutenant-Governor, Council and Affembly, That a sum, not ex- Loan to Gocceding Five Thousand Pounds, in Treasury Notes, be lent to the Governors of the faid vernors College for five years, on the terms and conditions herein after expressed; and shall be drawn from the Frealury of the Province, by warrant from His Excellency the Lieutenant-Governor, or Commander in Chief, for the time being, in favor of the Goversions of the faid College.

II. And be it also enacted, That the Movies in the British Funds, belonging to the said Security College, being Eight Thousand Two Hundred and Eighty-nine Pounds Nine Shillings and Six Pence sterling, of Three per Cent. Confolidated Annuities, shall be and stand pledged to the Province as security for the re-payment of the said sum of Five Thousand Pounds; and that the same shall be paid into the Treasury of the Province, whenever, after the faid five years, the same shall be required as herein after directed; and in order that the said Governors of the Dalhousie College may be enabled fully to carry into effect the provisions of this Act, they are hereby authorised to adopt such measures as may be necessary to enable the Trustees, in whose Names the said sum of Eight Thousand, Two Hundred and Eighty-Nine Pounds Nine Shillings and Six Pence, sterling, is in. vested in the Three per cent. Consolidated Anguities, to dispose of se much of the said fum of Money as shall be sufficient to repay to the Province the sum of Five Thousand Pounds, lent to the Governors of the said College: provided, The same shall be required by a Resolution of the House of Assembly of this Province, after the expiration of the faid five years.

III. And be it further enacted, That the faid Building, called Dalhouse College, with Additional the Ground pertaining to the same, be, and the same are hereby pledged, to the Pro-Security vince, as an additional fecurity, for the re-payment of the faid fum of Five Thousand Pounds, and are hereby made liable for the re-payment of the faid Sum of Five Thou-

fand Pounds, or such part thereof as thall be due after the expiration of the said term of sive years; provided, The said sum of Money in the said Three per Cent. Consolidated annuities shall be insufficient to discharge the same.

## CAP. VIII.

An ACT to continue an Act, entitled, An Act for the Summary Trial of Actions.

Act 3d. Gen. IV. continued BE it enacted by the Lieutenant-Governor, Council and Assembly, That the Act, perfect in the third Year of His present Majesty's Reign, entitled, An Act for the Summary Trial of Actions; and every matter, clause and thirg, in the said Act contained, shall be continued, and the same is hereby continued, for one Year, and from thence to the end of the next Session of the General Assembly.

## CAP. IX.

An ACT in addition to and amendment of an Act, entitled, An Act to regulate the Appointment of Collectors, and other Officers of Impost and Excise.

Districts for collection of Duties enlarged or limited E it engated by the Lieutenant-Governor, Council and Assembly, That, from and after the publication of this Act, it shall and may be lawful for the Governor, Lieutenant-Governor, or Compander in Chief for the time being, to enlarge or limit any of the Districts or Ports for which any Collector of Impost and Excise both been, or shall hereafter be, appointed, and to define the limits and bounds of such District or Port in the Commission of such Collector, any thing in the said Act to the contrary not with standing

## CAP. X.

An ACT to repeal an Act, passed in the sisty-ninth year of His late Majesty's reign, entitled, An Act to authorise a Drawback of certain Duties, and to regulate the manner of obtaining the same.

Act 59th. Geo. 111. repealed DE it enacted by the Lieutenant-Governor, Council and Assembly, That the Act, made and passed in the sitty-ninth year of His late Majesty's reign, entitled, An Act to authorise a Drawback of certain Duties, and to negulate the manner of obtaining the same, and every clause and thing therein contained, be, and the same is hereby, repealed.
