In Ordinance to provide for the Support & Maintenance of Bastard Philoren, and for punishing the Mother and Reported Father Milled in all well regulated Tovernments, Vice and Immorality ought to be discountenanced and restrained as for as the Legal and Constitutes authorities of the Country will admit. And Where af no provision has hitherto been made for the Maintenance & Sujoport of Bastaro Children, but have been left a Burthen on the Humanity of Individuals; and the Mother & Teputed Father suffered to escape the punishment which the Laws of England have wisely applied to restrain such Immoral and Vicious practices -() Plit therefore Ordaines & Orvered by His Honor Major General John Desparo, President of His Majesty's Council & Commanding His Majestys Forces in the Island of Cape Breton, by and with the advice and Consent of His Majesty, Council _ Moth is hereby Ordained & Owered, that from and after the publication hereof, if any Woman shall be Oelwered of a Bartaro Chies, which shall be Chargeable to this Government, or any place therein, The having reclared to the Midwife, or any person afirting her at the time of Delivery, Who is the Father of such Child, and shall have at some time previous there to seclared herself to be with Chies, and that such Chilois likely

to be born a Bastard and become Chargeable to the faublic or any place within the Tovernment, in either of such Cares upon Examination to be taken in witing upon Oath before any of his Majesty's Surtices of the Deace in and for the said Island or its Dependencies; Charge any person with having gotten Her with Chied- It shall and may be lawful for su Justice upon application made to him by the Church Wardens, Overseers of the Door, or any one of them, or any Substantial and respectable House Holder in the place where or near to where the Woman resides - To ifine out his Starrant to apprehend such person so charged as aforesaid, and cause the said person to be brought before him or some other of His Majerty's Justices of the peace and to Commit such person to Goal, unless he gives security to Indemnify the public or place from Maintaining or Supporting such Child on Phildren, and shall enter into Recognizance with Sufficient Jureties for his appearance at the next General Tessions where his Vecognizance shall be Continued, until The Woman is relivered of such Children - Trovided that if such Homan shall die or be married previous to her Delivery or Miscarry of such Child or Children, or shall appear not to have been with Chied at the time of Bur Camonation, such person shall be discharged from As Herognizance at the next Tessions or immediately teleast out of Custody if Committee -Berit

De it also Ordained and Ordered by the Muthouty aforesaid that any two furtices of the peace upon Complaint made by the Church Wardens Overseens of the poor, or any one of them, or of any Substantial Householder as aforesaid upon due Camination of the Cause and Circumstances shall and may of their Discretion make an Own that the Mother or Reputed Father of any Barbard Chied or Children, shall find sufficient Tecurity, that such Child or Children shall not become buthersome or chargeable to the public, or pay the Tum of Twenty Downds, which hall be paid into the Hands of the Church Wardens or Overseers of the Poor for the support of such Child or Children, or other Dublic Uses _ And if after the said Order made as aforesaid and directed to the Church Wardens, or Overseers of the poor, either the Father or Mother upon notice there of shace not for his or her part observe and perform the said Ower, such party making default to be Committee to the Common Goal for the space of six months. There to be employed and kept to hard Labour, in any way found to be practicable and necessary sowards his suffsoit and maintenance while He shall remain in Custody, except He, The or they shall give sufficient Security to perform said Order, or else personally to appear at the next.
Sessions of the Deace and abide by such Order as shall then and there be made in that be half, amois no Order shall be made at said Sessions. then to abide by the first Order aforesaid that in case any Woman shall accuse or Change any

Man with having gotten Her with Chieo, or that the Chieo be not really his, but appears to be only a Continuance to defame the Denson or Cheat him of his Money, that in such case the said Woman shall be sent to Goal there to be Whipped and Temain for the space of hix Months. Forsided Mewertholefs that if any person shace think himself wrong fully changed, or if the Woman, change frim be of ill fame, or al Common whose upon such Cases upon from be of ill fame, or al Common whose upon of quing Lecurity to abide the Judgement of the Court, He may apopoeal from the Ower of the Tustices to the next General Lession when the whole Cause may be heard and hier by such Court on the Versich of a Sury -Approved.
