THEREAS it is expedient further to continue An Act passed in the Thirty sixth year of the Reign of His present-Majesty, inituled, "An Att for making a " temporary Provision for the Regulation of Trade, between this Province and the United " States of America, by Land or by Ihland Navigation," Be it therefore enacted by the King's Most Excellent Majesty; by and with the advice and confent of the Legislative. Council and Assembly, of the Province of Lower Canada, constituted and assembled by Virtue of and under the authority of an Act of the Parliament of Great Britain, intituled, " An Act to repeal certain parts of an Act passed in the fourteenth year of His " Majesty's Reign, intituled, " An Act for making more effectual Provision for the Government " of the Province of Quebec in North America, and to make further Provision for the Govern-" ment of the faid Province," And it is hereby enacted by the authority of the same, that the faid Act, intituled, " An Act for making a temporary Provision for the Regulation of "Trade, between this Province and the United States of America, by Land or by Inland Naviga-" tion," and all matters and things therein contained, shall continue and be in force, until the first of January, one thousand eight hundred, and from thence to the end of the then next Sellion of the Provincial Parliament, and no longer; Provided always, that all and every order or orders issued and published, under the authority of the aforesaid Act, or which shall be issued or published, under the authority of this Act, shall not continue and be in force, longer than to the said first of January, one thoufand eight hundred, and from thence to the end of the then next Session of the Provincial Parliament.

Provided that the orders &c under that A&, shall continue no longer than the til January 1800.

[]HEREAS provisional articles of Agreement were entered into on the twenty eighth day of January, in the thirty seventh year of Your Majesty's Reign, by Commissioners nominated and appointed on behalf of this Province, to treat with Commissioners nominated and appointed on behalf of the Province of Upper Canada, which faid Articles of Agreement were ratified and confirmed by An Act of the Legislature of this Province passed also in the thirty seventh year of Your Majesty's Reign, intituled, " An Ast to ratify, Approve and Confirm certain Provisional Articles of "Agreement, entered into by the Respective Commissioners of this Province and Upper Canada. " at Montreal, on the twenty eighth day of January, one thousand seven hundred and ninety feven, relative to Duties and for carrying the same into effect," which said Articles of Agreement, have not hitherto been ratified, approved and confirmed by the Legislature of Upper Canada: And whereas, another Act was passed by the Legislature of this Province in the thirty-eighth year of Your Majesty's Reign, intituled, " An Ast " to repeal An Act passed in the thirty-sixth Year of the Reign of His present Majesty and " for appointing other Commissioners on behalf of this Province, to treat with Commissioners, on " behalf of the Province of Upper Canada and for the Purposes therein mentioned," in virtue whereof Additional Provisional Articles of Agreement were made and entered into at Montreal, on the eleventh day of February, in the thirty ninth year of Your Majesty's Reign, by a competent number of the Commissioners thereby nominated and
