Continuance of this Act.

V. And be it further enacted by the authority aforesaid, that this Act shall continue in force until the first day of March, which will be in the year of our Lord one thoufand eight hundred and one, and from thence to the end of the then next Session of the Provincial Parliament and no longer.

CAP. V.

An Act to give further Powers to the Executive Government to prevent the introduction or spreading of infectious or contagious Diseases in this Province.

(20th MAY, 1800)

Preamble.

HEREAS it is necessary to give further powers to the Executive Government, to prevent the introduction or spreading of infectious or contagious. Diseases, than are provided for by the Act of thirty fifth of His present Majesty chapter fifth, intituled. "An Act to oblige Ships and Veffels coming from places infected with the plague or " a y pellilential Fever or D: seaf., to perform Quarantine, and prevent the communication "thereof in this Province." Be it therefore enacted by the King's most Excellent Majesty, by and with the advice and consent of the Leastlative Council and Assembly of the Province of Lower Canada, conflituted and affenibled by virtue of and under the authority of an Act puffed in the Parliament of Great Britain, intituled "An Act to " repeal certain parts of an Act passe: in the sourteenth year of His Majesty's Ringn, intituled, " An Act for making more effectual provision for the Government of the Province of Quebec, in " North America, and to make further provision for the Coveriment of the said Province." And it is hereby enacted by the authority of the same, that it shall and may be lawful for His Excellency the Governor, Lieutenant Governor or Perlon administering the Government of this Province for the time being, by and with the advice and content of

His Majesty's Executive Council for this Province, to give such orders and directions

Duty of the Master of Port. III. And be it further enacted, that it shall be lawful for the Master of the Poit or other person or persons so appointed by His Excellency to examine, Vessels arriving, to give such immediate orders to the Master or Masters relating to their anchoring at a distance from the Town or from other ships, or to prevent persons from landing from on board of them, or persons from on shore going on board, or for personsing Quarantine, as to the said Master of the Port or person or persons so appointed, shall in his or their discretion appear immediately necessary, by reason of any contagious or infectious disease or diseases on board of such arriving Vessel or Vessels: And all and every Master or Masters, Commander or Commanders of Ships or Vessels from Sea, who shall refuse or neglect to obey the order in writing of the Captain of the Port, or other person, appointed by His Excellency the Governor, Lieutenant Governor or Person administering the Government, for the purposes of this Act, shall incur a penalty of twenty five Pounds sterling, for each and every such his disobedience.
