HEREAS in pursuance of the Address of the House of Assembly, bearing date the fourth day of April one thousand eight hundred and one, the sum of four Thousand Pounds current money of this Province, by Your Majesty's Orders has been issued and advanced to the Commissioners appointed by virtue of and under the authority of an Act passed in the thirty ninth year of Your Majesty's Reign, intituled, " An Ast for erecting Court Houses with proper Offices in the several Districts of " Quebec and Montreal, and for defraying the expences thereof," May it therefore please Your Majesty that it may be enacted, and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Affembly of the Province of Lower Canada, constituted and affembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, " An Act to repeal certain parts of an Act, passed in the fourteenth year of His Ma-" jefty's Reign, intituled, " An Att for making more effectual provision for the Govern-" ment of the Province of Quebec, in North America," and to make further provision for " the Government of the faid Province," and it is hereby enacted by the authority aforesaid, that out of the surplus of any fund or funds, subject to the disposition of the Provincial Parliament, under the authority of an A& passed in the thirty fifth year of His Majesty's Reign, intituled, " An Act for granting to His Majesty additional " and 'new Duties on Goods, Wares and Merchandizes and for appropriating the " same towards surther defraying the charges of the Administration of Justice and sup-" port of the Civil Government within this Province, and for other purpofes therein " mentioned." and also, under and by virtue of another Act passed in the thirty fifth year of His Majesty's Reign, intituled, " An Act for granting to His Majesty, Duties on Licence to Hawkers, Pedlars and Petty Chapmen, and for regulating their " Trade, and for granting additional Duties on Licences to persons for keeping Houses " for Public Entertainment or for retailing Wine, Brandy, Rum or other Spirituous "Liquors in this Province, and for regulating the same, and for repealing the Act or Ordinance therein mentioned, and also under and by virtue of another Act, passed in the forty first year of His Majesty's Reign, intituled, " An Act for granting to His Majesty certain new Duties on the Importation into this Province of all " manufactured Tobacco, and Snuff, and for disallowing the Drawback on Tobacco.
