AN ACT for applying certain sums of money therein mentioned; to make good the like sums issued and advanced by His Majesty's Orders, in pursuance of two several Addresses of the House of Assembly.

(5th April, 1802.

" MOST GRACIOUS SOVEREIGN,

Preamble.

WHEREAS in pursuance of the Address of the House of Assembly, bearing date the fourth day of April one thousand eight hundred and one, the sum of four Thousand Pounds current money of this Province, by Your Majesty's Orders has been issued and advanced to the Commissioners appointed by virtue of and under the authority of an Act passed in the thirty ninth year of Your Majesty's Reign, intituled, " *An Act for erecting Court Houses with proper Offices in the several Districts of Quebec and Montreal, and for defraying the expences thereof,*" May it therefore please Your Majesty that it may be enacted, and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, " *An Act to repeal certain parts of an Act, passed in the fourteenth year of His Majesty's Reign, intituled, " An Act for making more effectual provision for the Government of the Province of Quebec, in North America,*" and to make further provision for the Government of the said Province," and it is hereby enacted by the authority aforesaid, that out of the surplus of any fund or funds, subject to the disposition of the Provincial Parliament, under the authority of an Act passed in the thirty fifth year of His Majesty's Reign, intituled, " *An Act for granting to His Majesty additional " and new Duties on Goods, Wares and Merchandizes and for appropriating the same towards further defraying the charges of the Administration of Justice and support of the Civil Government within this Province, and for other purposes therein mentioned.*" and also, under and by virtue of another Act passed in the thirty fifth year of His Majesty's Reign, intituled, " *An Act for granting to His Majesty, Duties on Licence to Hawkers, Pedlars and Petty Chapmen, and for regulating their Trade, and for granting additional Duties on Licences to persons for keeping Houses for Public Entertainment or for retailing Wine, Brandy, Rum or other Spirituous Liquors in this Province, and for regulating the same, and for repealing the Act or Ordinance therein mentioned,*" and also under and by virtue of another Act, passed in the forty first year of His Majesty's Reign, intituled, " *An Act for granting to His Majesty certain new Duties on the Importation into this Province of all manufactured Tobacco, and Snuff, and for disallowing the Drawback on Tobacco manufactured within this Province,*" and now remaining in the hands of the Receiver General of this Province, unappropriated, there shall be issued and applied the sum of four Thousand Pounds, current money of this Province, to make good the like sum, which has, so as aforesaid, been issued and advanced, by His Majesty's Orders, in pursuance of the aforesaid Address of the House of Assembly.
