are hereby repealed. Provided always, that the Rules and Orders of Police, now in force, under those or either of those Acts or Ordinances, shall have the same force and effect, as if this Act had not been made, from and after the passing of the same, until the end of the next General Quarter Sessions of the Peace for the District, where such Rules and Orders, respectively, have effect, and from thence, to the end of the then next Superior Term of the Court of King's Bench, for the said District, and no longer, any thing herein contained to the contrary notwithstanding.

Continuance of this Act.

XIII. And be it further enacted by the authority aforesaid, that this Act shall have continuance and be in force, until the first day of January, which will be in the year one thousand eight hundred and seven, and from thence to the end of the then next Session of the Provincial Parliament and no longer.

C A P. IX.

AN ACT to continue for a limited time and amend an Act passed in the thirty ninth year of His Majesty's Reign, intituled, "*An Act for granting further encouragement, and a more ample allowance to the Maitres and Aides de Poste, in this Province.*"

WHEREAS an Act was passed by the Legislature of this Province, in the thirty ninth year of His Majesty's Reign, intituled, "*An Act for granting further encouragement and a more ample allowance to the Maitres and Aides de Poste in this Province,*" which Act is to have continuance until the end of the present Session of the Provincial Legislature, and whereas it is expedient that it be continued and amended as herein after mentioned, Be it therefore enacted by the King's most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "*An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled, 'An Act for making more effectual Provision for the Government of the Province of Quebec, in North America, and to make further Provision for the Government of the said Province,*" And it is hereby enacted by the authority of the same, that the said Act, intituled, "*An Act for granting further encouragement and a more ample allowance for the Maitres and Aides de Poste in this Province,*" and all matters and things therein contained, shall continue to be in force, until the first day of January one thousand eight hundred and three, and from thence to the end of the then next Session of the Provincial Parliament and no longer.

And continued.

Maitres or Aides de Poste not entitled to any Fare unless they have sufficient Reins to their Horses.

II. And whereas great inconvenience hath arisen from the *Maitres de Poste* and their Aides, driving horses without sufficient harness, and more particularly, (when two horses are required) by driving the said horses with reins only to one of the same. It is therefore enacted by the authority aforesaid, that no *Maitre de Poste* or *Aide de Poste*, shall be entitled to demand or receive any fare or hire, for any carriage or horses when

when he or they may drive two horses, without good and sufficient reins to each of the horses harnessed to any carriage of what nature soever.

WHEREAS it is expedient further to continue an Act passed in the forty first year of His Majesty's Reign, intituled, "*An Act for the relief of Persons holding Lands or Immoveable Property of His Majesty, en Rôture, upon which Lots et Ventes or Mutation Fines are due.*" Be it therefore enacted by the King's most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act of the Parliament of Great Britain, intituled, "*An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled, 'An Act for making more effectual Provision for the Government of the Province of Quebec in North America;' and to make further Provision for the Government of the said Province,*" and it is hereby enacted by the authority of the same, that the said Act intituled, "*An Act for the relief of Persons holding Lands or Immoveable Property of His Majesty en Rôture upon which Lots et Ventes or Mutation Fines are due,*" and all matters and things therein contained, shall continue and be in force until the eighth day of July, which will be in this present year of our Lord, one thousand eight hundred and two, and no longer, any thing contained in the said Act to the contrary notwithstanding. Provided always, that all and every petition or demand for a pecuniary composition on *Lots et Ventes* due to His Majesty, shall be proposed and presented to the Commissioners appointed by virtue of the aforesaid Act, on or before the eight day of the month of June next, and not afterwards.

No petition or demand for a pecuniary composition to be received after 8th. of June next.

C A P. XI.

AN ACT to empower the Justices of the Peace, to make, for a limited time, Rules and Regulations for the government of Apprentices and others.

Preamble

WHEREAS the Laws in force in this Province have hitherto been found insufficient, to regulate, rule and govern Apprentices, Domesticks, hired Servants and Journeymen, And Whereas great inconveniencies and disadvantages result to the Community, Agriculture, Commerce and Tradesmen of all descriptions, from the inefficacy
