II. Provided nevertheless, and be it further enacted by the authority aforesaid, that nothing herein contained shall be construed or taken to confirm any Marriage between persons who, at the time of the Celebration of such Marriage, could not legally intermarry with each other, nor to confirm any Marriage which shall be celebrated after the passing of this Act.

C A P. XII.

An Act to make good the deficiency of the Funds by Law provided for paying the Salaries of the Officers of the Legislative Council and House of Assembly, and the Contingent expences thereof.

MOST GRACIOUS SOVEREIGN,

Preamble.

WHEREAS the Funds provided by an Act passed in the thirty third year of Your Majesty's Reign, intituled, "*An Act to establish a Fund for paying the Salaries of the Officers of the Legislative Council and Assembly, and for defraying the contingent expences thereof,*" have been insufficient for that purpose; And Whereas the Sums necessary to make good the said deficiency have, from time to time, on Addresses from the Legislative Council and House of Assembly respectively, been advanced by Your Majesty's Orders, the which deficiency amounts to the Sum of Three thousand three hundred and ninety one Pounds, seven Shillings and ten Pence Current money of this Province, exclusive of the charges of collection and the drawbacks allowed to the Province of Upper-Canada: May it therefore please Your Majesty that it may be enacted, and be it enacted by the King's most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "*An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled, 'An Act for making more effectual provision for the Government of the Province of Quebec in North America,'*" and to "*make further provision for the Government of the said Province;*" And it is hereby enacted by the authority of the same, that all and every the Sum or Sums which have been so advanced by Your Majesty's Orders to the sixth day of March One thousand eight hundred and four inclusive, for the before mentioned purposes amounting to Three thousand three hundred and ninety one Pounds, seven Shillings and ten Pence Current money of this Province, together with the charges of collection and the drawbacks allowed to the Province of Upper-Canada, shall be and are hereby directed to be charged to and against the surplus of any Fund or Funds subject to the disposition of

And be it further enacted by the authority aforesaid, that the due application of the Sum or Sums directed to be charged as aforesaid to make good and pay any deficiency as aforesaid, as by this Act is directed, shall be accounted for to His Majesty, His Heirs and Successors through the Lords Commissioners of His Majesty's Treasury in such manner and form as His Majesty, His Heirs and Successors shall direct.
