WHEREAS an Act was passed by the Legislature of this Province in the fortieth year of His Majesty's Reign, intituled, " An Act to give further powers to the · Executive Government to prevent the introduction or spreading of infectious or contaes gious diseases in this Province," which Act is to have continuance only until the end of the present Session of the Legissature; and Whereas it is expedient and necessary further to continue the said Act: Be it therefore enacted by the King's most Excellent Majesty, by and with the advice and confent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act of the Parliament of Great Britain, intituled, " An Act to re-" peal certain parts of an Act passed in the sourteenth year of His Majesty's Reign, intituled, "An Act for making more effectual Provision for the Government of the Pro-" vince of Quebec in North America;" and to make further Provision for the Govern-" ment of the faid Province;" and it is hereby enacted by the authority of the same, that the faid Act, intituled, " An Act to give further powers to the Executive Govern-"ment to prevent the introduction or spreading of infectious or contagious difeases in this " Province," and all matters and things therein contained, shall continue and be in force until the first day of January one thousand eight hundred and eight, and from thence to the end of the then next Session of the Provincial Parliament, and no lon-

CAP. VII.

An Act for the more easy administration of Oaths to Witnesses before the Grand-Jury.

(2d May, 1804)

Preamble.

WHEREAS it will contribute to the dispatch of business in Courts of Criminal Jurisdiction, that Oaths to Witnesses before the Grand Jury should be administered without recursing to the Court for that purpose: Be it therefore enacted by the King's most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled

The Foreman of the Grand Jury empowered to administer, in their pretence, the ufual oath to Persons appearing as Wi .neffesbefore them. The faid Oath to behinding in Law. sembled by virtue of and under the authority of an A& passed in the Parliament of Great Britain, intituled. House of Assembly of the Province of Lower Canada having taken into our most serious consideration the expediency of granting further encouragement to promote the Culture of Hemp in this Province: May it please your Majesty that it may be enacted, and Be it enacted by the King's most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled " An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled, " An Act for " making more effectual Provision for the Government of the Province of Quebec in North " America;" and to make further provision for the Government of the said Province; And it is hereby enacted by the authority of the same, that it shall and may be lawful for the Governor, Lieutenant Governor or Person administering the Government for the time being, out of any unappropriated monies that now are or may be in the hands of the Receiver General of this Province, to apply a further fum not exceeding twelve hundred Pounds, Current money of this Province, to enable the Inhabitants to enter on the culture of Hemp with facility and advantage, and the faid fum herein appropriated shall be applied in such manner and under such regulations as His Excellency the Governor, Lieutenant Governor or Person administering the Government for the time being shall judge most expedient for promoting the ends of this Act.
