Preamble.

HEREAS it appears by the Report of the Commissioners appointed by His Excellency the Lieutenant Governor, under the Act of the Legislature passed last Session, intituled " An Att for applying the sum of One Thousand Pounds out of any unappropriated monies in the hands of His Majesty's Receiver General, towards the improvement of the Inland Navigation of this Province," that the effect of the work already done in the removal of some of the impediments in the rapids of Saint Louis in the River Saint Lawrence near to la Chine, has surpassed their expectations; and that it would be of great benefit to complete the same; and also to remove the impediments in the navigation for batteaux from Montreal to Lake Saint Francis, but more especially beyond la Chine: May it therefore please your Majesty that it may be enacted, and be it enacted by the King's most Excellent Majesty by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada constituted and assembled by virtue of and under the authority of an Act of the Parliament of Great Britain, intituled, " An Act to repeal certain parts of an Act passed in the fourteenth " year of His Majesty's Reign, instituted, An Act for making more effectual provifion for the government of the Province of Quebec in North America," and to-make " further provision for the government of the faid Province;" and it is hereby enacted by the authority of the same, That it shall and may be lawful to and for the Governor, Lieutenant Governor or Perlon administering the Government of this Province, by warrantor warrants under his hand and feal directed to His Majefty's Receiver General of the same, to issue to the above said Commissioners, or to any two of them, a further fum or fums of money not exceeding in the whole one thousand Pounds, current money, out of any unappropriated monies which now are
