

as may at any time, hereafter remain unpaid or unsatisfied (save and except the Holders of army bills as have been issued subsequent to the passing of the former Act) to receive payment out of any monies in the hands of the Receiver General.

hereafter remain unpaid or unsatisfied, save and except the holder or holders of such Army Bills, as were heretofore issued, subsequent to the passing of the Act to facilitate the circulation of Army Bills, and until the same exceeded in the whole the sum of Two Hundred and fifty Thousand Pounds, and which now remain unpaid and unsatisfied, to receive out of or from any monies that may be in the hands of the Receiver General in this Province, or from any monies that may hereafter come into his hands, arising out of any taxes or duties heretofore imposed, or that may hereafter be imposed, levied or raised by virtue of any Act of the Provincial Legislature, or from the rents and revenues of His Majesty's territorial Domains in this Province, or from any other monies in the hands of the Receiver General, payment of any such Army Bill or Bills as aforesaid.

Director, &c. of the Army Bill Office indemnified for having issued army bills beyond the sum of £500,000, limited by Act 53, Geo. III, cap. 3.

XVII. And be it further enacted by the authority aforesaid, that the Director of the Army Bill Office, and all and every person or persons aiding and assisting him in the making and issuing of Army Bills over and above the sum of Five Hundred Thousand Pounds, as limited by the Act Fifty-third George Third, Chapter third, shall be freed, discharged and indemnified as well against the King's Majesty, his Heirs and Successors, as against all and every other person or persons of, for or concerning the making and issuing of all, any and every such Army Bills, as shall have been so made and issued beyond the said limitation.

An Act to continue two several Acts therein mentioned for regulating the Fisheries in the inferior District of Gaspé.

WHEREAS an Act was passed by the Legislature of this Province in the forty-seventh year of His present Majesty's Reign, intituled, "An Act for the better regulation of the Fisheries in the inferior District of Gaspé, and to repeal an Act or Ordinance therein mentioned," and whereas the provisions of the said Act were amended by an Act passed by the Legislature of this Province in the forty-eighth Year of His present Majesty's Reign, intituled, "An Act to amend an Act passed in the forty-seventh Year of His Majesty's Reign, intituled, *An Act for the better regulation of the Fisheries in the inferior District of Gaspé, and to repeal an Act or Ordinance therein mentioned,*" and to make further regulations for the said Fisheries; And whereas the said Acts are in force only to the first day of May in the present year of our Lord, one thousand eight hundred and fourteen, and that it is expedient that the same should be continued—Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada,

Canada, constituted and assembled by virtue of and under the authority of an Act of the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth Year of His Majesty's Reign, intituled, "An Act for making more effectual Provision for the Government of the Province of Quebec in North America," and to make further provision for the Government of the said Province;" And it is hereby enacted by the authority of the same, that the said before recited Acts and all matters and things therein contained, shall continue and be in force until the first day of June one thousand eight hundred and sixteen, and no longer.

An Act further to continue, for a limited time, two several Acts therein mentioned to provide Temporary Houses of Correction in the several Districts of this Province.

WHEREAS an Act was passed in the fifty-first Year of His Majesty's Reign, intituled, "An Act to provide Temporary Houses of Correction in the several Districts of this Province," the which Act was continued and amended by an Act passed in the fifty-second year of His present Majesty's Reign, intituled, "An Act to amend an Act passed in the fifty-first year of His Majesty's Reign, intituled, "An Act to provide Temporary Houses of Correction in the several Districts of this Province," the which said Acts will continue and remain in force until the first day of May of the present year one thousand eight hundred and fourteen; and whereas it is expedient and necessary further to continue the said Acts: Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth Year of His Majesty's Reign, intituled, "An Act for making more effectual Provision for the Government of the Province of Quebec in North America," and to make further provision for the Government of the said Province," and it is hereby enacted by the authority of the same, that the said two before recited Acts, and all matters and things therein contained, shall continue and be in force until the first day of May, one thousand eight hundred and sixteen, and no longer.
