

have been purchased, a deduction of eight pence upon every minot of Salt so as aforesaid purchased, any Law, Usage or Custom to the contrary, in any wise notwithstanding.

No recovery or deduction allowed upon salt between a certain period, and only of those persons who have received, a certain sum for salt imported or sold by them.

VI. Provided always, and it is hereby enacted, that no such recovery or deduction aforesaid, shall be had and allowed, except upon Salt purchased between the first day of May last and the first day of May in the present year of our Lord, and against those persons only who under and by virtue of this Act, have been allowed or received the said sum of eight pence upon every minot of Salt by them imported and sold as aforesaid.

## C A P IX.

An Act for applying a further Sum of Money, towards the erecting a Common Gaol, with a Court Hall, at New-Carlisle, in the inferior District of Gaspé.

(17th March, 1814.)

Preamble.

WHEREAS the Sum already appropriated by law, for the purpose of erecting a Common Gaol with a Court Hall, at New Carlisle in the inferior District of Gaspé, it's been found insufficient, and that it appears expedient to apply a further Sum of money, for the erecting and completing the said Common Gaol, with a Court Hall, and the appendages thereof, may it therefore please Your Majesty that it may be enacted, and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled; "An Act to repeal certain parts of an Act passed in the Fourteenth Year of His Majesty's Reign, intituled; " *An Act for making more effectual provision for the Government of the Province of Quebec in North America,*" And to make further provision for the Government of the said Province;" and it is hereby enacted by the authority of the same, that it shall and may be lawful for the Governor, Lieutenant Governor or the Person administering the Government, for the time being, by Warrant or Warrants, under his Hand and Seal, directed to the Receiver General of this Province, to issue to the Commissioners or any two of them appointed or who may hereafter be appointed, for the erecting the said Common Gaol with a Court Hall at New Carlisle aforesaid, by virtue of and under the under the authority of an Act passed in the Forty-eighth year of Your Majesty's Reign, intituled, "An Act for erecting Common Gaols with Court Halls in the Inferior District of Gaspé," a further Sum of Money not exceeding in the whole, One Thousand one hundred Pounds, current money of this Province, out of any unappropriated monies which now are or hereafter may be in the hands of the said Receiver General to be applied towards

towards the building and completing of the said Common Gaol and Court Hall and the Appendages thereof.

II. And be it further enacted by the authority aforesaid, that it shall and may be lawful for His Excellency the Governor, Lieutenant Governor or Person administering the Government, for the time being, to make to the Treasurer and Clerk who may be appointed, under and by the authority of the aforesaid Act, to the Commissioners for the erecting of the aforesaid Common Gaol, with a Court Hall, at New-Carlisle aforesaid, a further allowance for his time, services and contingent Expences, not exceeding in the whole, the sum of Twenty pounds, current money of this Province, out of the sum granted in and by the present Act.

III. And be it further enacted by the authority aforesaid, that the said Commissioners for the erecting of the said Common Gaol, with a Court Hall, at New-Carlisle aforesaid, when thereunto required shall account to the Governor, Lieutenant Governor or Person administering the Government of this Province, for the time being, for the application and expenditure of all and every the sum and sums of money, to be advanced to them, in conformity to this Act, in such manner and form as the Governor, Lieutenant Governor or Person administering the Government of this Province, for the time being, shall appoint and direct.

IV. And be it further enacted by the authority aforesaid, that due application of the said monies, pursuant to the directions of this Act, shall be accounted for to His Majesty, His Heirs and Successors, through the Lords Commissioners of His Majesty's Treasury, in such manner and form as His Majesty shall direct.

V. And be it further enacted by the authority aforesaid, that the aforesaid Act, made and passed in the forty-eighth year of His Majesty's Reign, intituled, "An Act for erecting Common Gaols, with Court Halls, in the Inferior District of Gaspé," and every Clause, matter and thing therein contained, in so far as the same is not altered by this Act, shall be and continue in force, the same as if this Act had never been made.
