Mot to annul or proceedings of or proceedings or the commission-ers by reason of any insufficiency of Law, or to al-ter any judgment touching the powers of such dommissioners.

II. Provided always, and be it further enacted by the authority aforesaid, that any objections nothing in this Act contained, shall extend or be construed to extend to avoid or annul any objection made to such acts or proceedings of the said Commissioners for or by reason of any insufficiency, irregularity, defect or matter of Law whatsoever, or in any manner or way to affect, change or alter any Judgment or Judgments of any or either of His Majesty's Courts of Law in this Province, which may have been given touching or concerning the Commissions, Powers or Authorities of fuch Commissioners as aforesaid, or of any or either of them already made.

TATHEREAS by an Act passed in the fifty-third year of His Majesty's Reign, intituled, "An Act to grant certain Duties to His Majesty towards supply-66 ing the wants of the Province during the present war with the United States of "America, and for other purposes," which said Act was, by another Act passed in the fifty-eighth year of His Majesty's Reign, intituled, " An Act to continue for a limited time, the levying of the Duties imposed by the Act of the fifty-" third year of His Majesty's Reign, Chapter the eleventh, as amended by the " Act of the fifty-fifth year of His Majesty's Reign, Chapter the second," further continued for a limited time, a duty of two pounds ten shillings, currency, is imposed on every hundred pounds worth of goods, wares and merchandize which should thereafter be imported into this Province, from any place or country whatfoever, by any person or persons whatsoever, with the exception of certain articles enumerated in the fifth Clause of the A& first above mentioned; And whereas it is expedient also to exempt Seeds, Rye, Oats, Barley, Potatoes, Indian Corn, Beans, Peale, Rice and Grain of all kinds, and Horles, Neat Cattle, Sheep, Hogs, Poultry and other Live Stock, and live provisions of all kinds, as well as Puch, Tar. Turpentine, Rolin, Hemp and Flax, Butter, Cheese and Honey, from the said duty; Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and confent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and affembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal cer-" tain parts of an Act passed in the sourteenth year of His Majesly's Reign, intituled, " An Act for making more effectual provision for the Government of the Province of Quebec, in North America," and to make further provision for the Govern-" ment of the faid Province;" and it is hereby enacted by the authority of the fame,

Geo. 11L on Sundays and Holidays," which faid Act will expire on the first day of May, one thousand eight hundred and nineteen; And whereas it is expedient further to continue for a limited time, the aforesaid Act; Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the " fourteenth year of His Majesty's Reign, intituled, " An Act for making more efse fectual provision for the Government of the Province of Quebec, in North America," and to make further provision for the Government of the faid Province," And it is hereby enacted by the authority of the same, that the aforesaid act passed in the fifty-seventh year of His Majesty's Reign, intituled, " An Act to provide for the " maintenance of good order on Sundays and Holidays," and all and every the matters and things therein-mentioned and contained, shall continue and be in force until the firstday of May, one thousand eight hundred and swenty-one, and no longer.
