- A T the Provincial Parliament begun and holden at Quebec, the fourteenth day of December, Anno Domini, one thousand eight hundred and twenty, in the first year of the Reign of our Sovereign Lord GEORGE the Fourth, by the Grace of GOD, of the United-Kingdom of Great-Britain and Ireland, King, Defender of the Faith, and from thence continued by several Prorogations to the tenth day of January, one thousand eight hundred and twenty-three."

CAP. I.

An Act to continue for a limited time, two certain Acts therein-mentioned, relating to the Trial of Small Causes in the Country Parishes of this Province.

(22d March, 1823.)

WHEREAS it is necessary to continue for a limited time, an A& passed in the first year of His Majesty's Reign, intituled, "An A& for the Summary "Trial of certain Small Causes in the Country Parishes of this Province," as amended by an A& passed in the second year of His Majesty's Reign, intituled, "An A&

Presmble.

An Act to amen an Act passed in the first year of His present Majesty's Reign, " intituled, " An Act for the Summary Trial of certain Small Causes in the Country " Parishes of this Province," which said Ass were to expire on the first day of May, one thousand eight hundred and twenty-three; Be it therefore enacted by the King's most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain, intituled, "An Act to repeal certain parts of an Act pailed in the fourteenth " year of His Majesty's Reign, intituled, "An Att for making more effectual provi-" fion for the Government of the Province of Quebec, in North America," and to make "further provision for the Government of the said Province;" And it is hereby enacted by the authority of the same, that the aforesaid Act passed in the first year of His Majesty's Reign, intituled, 45 An Act for the Summary Trial of certain " Small Causes in the Country Parishes of this Province," as the same hath been amended by the aforesaid Act passed in the second year of His Majesty's Reign, intituled. "An Act to amend an Act passed in the first year of his present Majesty's "Reign, intituled, "An Act for the Summary Trial of certain Small Caufes in the " Country Parishes of this Province," and all and every the matters and thing in the faid two Acts mentioned and in force, shall continue to be and remain in force until the first day of May, one thousand eight hundred and twenty-five and no longer.
