

C A P. XXXI.

AN ACT to appropriate a certain Sum of Money therein mentioned for the Gaol, at Three-Rivers.

(21. March, 1823.)

MOST GRACIOUS SOVEREIGN.

Preamble.

WHEREAS it is expedient to appropriate a further Sum of Money for defraying certain additional expenses incurred and to be incurred with respect to the Gaol for the District of Three-Rivers; May it therefore please Your Majesty, that it may be enacted and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled, *An Act for making more effectual provision for the Government of the Province of Quebec, in North America*, and to make further provision for the Government of the said Province;" and it is hereby enacted by the authority of the same, that it shall be lawful for the Governor, Lieutenant-Governor, or Person administering the Government of the Province for the time being, by a Warrant or Warrants under his hand, to advance and pay from and out of the unappropriated monies that now are or that hereafter may come into the hands of the Receiver-General of the Province, the following sums of money, that is to say: a sum not exceeding four hundred pounds, currency, to reimburse the purchase money expended in the purchase of the lot of ground upon which the Gaol for the District of Three-Rivers is built; also, a sum not exceeding nineteen hundred and forty-three pounds, currency, to defray certain sums of money and arrears due to the Contractor for building, and to others for materials furnished and provided for the building and construction of the aforesaid Gaol, that is to say: to Olivier Larue, for Mason work, agreeable to a judgment by him obtained against the Commissioners for erecting the aforesaid Gaol, and to cover his costs and the interest due him in virtue of the judgment aforesaid, the sum of fourteen hundred and ninety-eight pounds, thirteen shillings and two pence, currency; to Michel Robitaille, for Carpenters' and Joiners' work, one hundred and twenty-seven pounds, twelve shillings and eleven pence, currency; to Louis and Joseph Lassieray, for iron work, two hundred and thirty-seven pounds, eight shillings and eleven

eleven pence, currency; to Charles Fortier, for nails, tin and other materials twenty pounds, ten shillings and five pence, currency; to Ezekiel Hart, for tin, twelve pounds, eight shillings and two pence, currency; to Moses Hart, for locks, hinges, paint and other materials, six pounds, ten shillings and two pence, currency; to Jacques Bureau, for linseed oil, eleven pounds, fourteen shillings, currency; to Benjamin Hart, for hinges, three pounds, two shillings and three pence, currency; to Louis Joseph Wolff, for painting, twenty-five pounds, currency; and also, a further Sum of one hundred pounds, currency, to enable the Commissioners for erecting the Gaol aforesaid, to defray certain necessary expenses in repairing and lengthening the eaves of the roof of the aforesaid Gaol.

II. And be it further enacted by the authority aforesaid, that the due application of the monies by this Act appropriated, shall be accounted for to His Majesty, His Heirs and Successors, through the Lords Commissioners of His Majesty's Treasury, for the time being, in such manner and form as His Majesty, His Heirs and Successors shall be pleased to direct.

C A P. XXXII.

AN Act to extend certain provisions contained in an Act passed in the fifty-seventh year of the Reign of His late Majesty, intituled, "An Act to provide Temporary Houses of Correction in the several Districts of this Province."

(22d March, 1823.)

Preamble.

WHEREAS by an Act passed in the fifty-seventh year of the Reign of His late Majesty, King George the Third of glorious memory, intituled, "An Act to provide Temporary Houses of Correction in the several Districts of this Province," it is provided, that it shall and may be lawful for the Governor, Lieutenant Governor, or Person administering the Government of this Province for the time being, to appropriate for the purposes of a House of Correction such part or parts of the new common gaols in the Cities of Quebec and Montreal, as may be vacant and which might be conveniently appropriated to that purpose; And whereas it is expedient to extend the above recited provision of the aforesaid Act, to the new common gaol in the town of Three-Rivers. Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain,
