51 George III – Chapter 2

An Act declaratory of the time at which the levying of certain Duties under and by virtue of an Act passed in the present Session of the Provincial Parliament, intituled, "An Act to continue for a limited time, the levying of the Duties imposed by the Provincial Act of the forty fifth year of His Majesty, George the third, chapter thirteenth, and for applying a certain sum of money for the purposes therein mentioned," shall take place, and for other purposes. (21st, March, 1811.)

Whereas, by an Act made and passed by the Legislature of this Province, during the present Session, intituled, "An Act to continue, for a limited time, the levying of the Duties imposed by the Provincial Act of the forty fifth year of His Majesty George the Third, Chapter thirteenth, and for applying a certain sum of money for the purposes therein mentioned," which Act received the Royal Sanction on the twelfth day of the present Month of March, one thousand eight hundred and eleven, and bears the same date, it is amongst other things enacted, that, from and after the twenty fifth day of March next, the respective duties imposed by the aforesaid Act of the forty fifth of His Majesty, Chapter thirteenth, shall continue to be levied, collected and paid, and that, in the said Act, certain words have been omitted in copying the same, which are essential. And whereas, doubts may arise in the execution of the said Act, which it is proper to obviate: Be it therefore enacted and declared by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of An Act passed in the Parliament of Great Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth Year of His Majesty's reign intituled, 'An Act for making more effectual provision for the Government of the Province of Quebec in North America,' and to make further provision for the Government of the said Province," and it is hereby enacted by the authority of the same, that the levying, receiving and paying of the said Duties so imposed by the afore-mentioned Act of the forty fifth of His Majesty, Chapter thirteenth, are by the afore-mentioned Act, passed in the present Session, intended to be, and shall continue to be levied received and paid from and after the twenty fifth day of March in the present year of our Lord one thousand eight hundred and eleven.

II. And be it further enacted by the authority aforesaid, that the words "with Estimates of the expence of such building," omitted in the English version of the twelfth clause of said Act, shall be considered to form of the said twelfth clause.

III. And be it further enacted by the authority aforesaid, that the monies so to be levied shall be for the use of His Majesty, his Heirs and Successors; the same as if more fully and amply enacted in and by the said Act.
