59 George III – Chapter 12

An Act for the better application of certain monies heretofore appropriated for the Internal Communications of the County of Northumberland. (24th April, 1819.)

Whereas by the sixth Clause of an Act passed in the fifty-seventh year of His Majesty's Reign, intituled, "An Act to make more effectual provision for the improvement of the Internal Communications of this Province," it is enacted that the works then remaining, to be done under an Act passed in the fifty-fifth year of His Majesty's Reign, intituled, "An Act to improve the Internal Communications of this Province," for making the Highway of Communication between the Parishes of Saint Pierre de la Baie Saint Paul, Saint Feréol [Saint-Ferréol] and Saint Joachim, should be made under the direction of the Commissioners of the Internal Communications for the County of Northumberland. And whereas a new road hath been traced in the course of last year, between the above-mentioned Parishes, which passes over land, more favorable to agriculture than the road heretofore opened, and is, in other respects, much more eligible than the said road. And whereas it is expedient that such monies as may at the time of passing this Act remain in the hands or be at the disposal of the above-mentioned Commissioners, should be exclusively appropriated to the opening and making of the said road, traced last year from the aforesaid Parish of Saint Pierre de la Baie Saint Paul, to or near the Parish Church of Saint Joachim, by way of the hill, commonly called the Côte de la Miche, in preference to the road already opened, in virtue of the first above-mentioned Act; Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, intituled, 'An Act for making more effectual provision for the Government of the Province of Quebec, in North America,' and to make further provision for the Government of the said Province," And it is hereby enacted by the authority of the same, that it shall be lawful for the Commissioners of Internal Communications of the aforesaid County of Northumberland, by and with the approbation and consent of the Governor, Lieutenant Governor, or Person administering the Government of the Province for the time being, exclusively to appropriate the monies remaining in the hands, or at the disposal of the aforesaid Commissioners for the purposes of the above-mentioned Acts, to the opening and making of the above-mentioned Road to or near the aforesaid Parish of Saint Pierre de la Baie Saint Paul, to the Parish Church of Saint Joachim, by way of the hill commonly called, the Côte de la Miche, of which road so as aforesaid traced, a descriptive Plan hath been drawn by Francois Fournier, Esquire, Land Surveyor.

II. And be it further enacted by the authority aforesaid, that the due application of the money which shall be expended in virtue of this Act, as above directed, shall be accounted for to His Majesty, His Heirs and Successors, through the Lords Commissioners of His Majesty's Treasury, for the time being, in such manner and form as His Majesty, His Heirs and Successors shall direct.
