3 George IV - Chapter 36

An Act to reimburse and make good a certain sum of money therein mentioned, expended towards defraying the expenses of the Civil Government, for the year one thousand eight hundred and eighteen. (22d. March, 1823.)

MOST GRACIOUS SOVEREIGN,

Whereas it is expedient to reimburse and indemnify Your Majesty's Government for a certain sum of money necessarily expended over and above the sum of money appropriated for the service of the Civil Government in this Province of Your late Royal Father, His Majesty King George the Third of Glorious Memory, for the year ending the thirty-first day of October, one thousand eight hundred and eighteen: We, therefore, Your Majesty's Most dutiful and Loyal Subjects, the Commons of Lower-Canada, in Provincial Parliament assembled, do most humbly beseech Your Majesty, that it may be enacted, and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain, intituled, "An Act to repeal certain parts of an Act passed in the Parliament of Great-Britain, intituled, 'An Act for making more effectual provision for the Government of the Province of Quebec, in North-America;' and to make further provision for the Government of the said Province;" and it is hereby enacted by the authority of the same, that the sum of eight hundred and ninety-eight pounds, sixteen shillings, and ten pence, sterling, being for a like sum disbursed towards defraying the expenses of the Civil Government in this Province, of His late Majesty King George the Third, for the year ending the thirty-first day of October, one thousand eight hundred and eighteen, over and above the sum of money appropriated for the year one thousand eight hundred and eighteen, in virtue of an Act of the Legislature of this Province, of the fifty-ninth year of the Reign of His late Majesty George the Third, intituled, "An Act to make good a certain sum of money therein-mentioned, advanced to defray the expenses of the Civil Government of this Province, for the year one thousand eight hundred and eighteen," shall be and the same is hereby authorized and directed to be reimbursed from and charged against the unappropriated monies in the hands of the Receiver-General of this Province, which may have been raised, levied and collected under and by virtue of any Act or Acts of the Legislature of this Province.

II. And be it further enacted by the authority aforesaid, that the due application be accounted for of the sum of money to be reimbursed and charged as by this Act directed, shall be accounted for to His Majesty, His Heirs and Successors, through the Lords Commissioners of His Majesty's Treasury for the time being, in such manner and form as His Majesty, His Heirs and Successors shall be pleased to direct.
