An Act to appropriate certain sums of Money, towards, enabling His Majesty to defray certain expenses therein-mentioned, appertaining to His Majesty's Civil Government in this Province, for the year one thousand eight hundred and twenty-three. (22d. March, 1823.)

MOST GRACIOUS SOVEREIGN,

Whereas it is expedient to appropriate a certain sum of Money to enable Your Majesty to defray certain Expenses appertaining to Your Majesty's Civil Government in this Province for the present year one thousand eight hundred and twenty-three; We therefore Your Majesty's Most dutiful and loyal Subjects, the Commons of Lower-Canada in Provincial Parliament assembled, do humbly beseech Your Majesty that it may be enacted, and be it enacted by the King's Most excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Lower-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great-Britain, intituled, "An Act to repeal certain parts of an Act passed in the fourteenth year of his Majesty's Reign, intituled, 'An Act for making more effectual provision for the Government of the Province of Quebec, in North America,' and to make further provision for the Government of the said Province"; and it is hereby enacted by the authority of the same, that it shall be lawful from and after the passing of this act, for His Majesty, or for the Governor, Lieutenant-Governor, or Person administering the Government of this Province for the time being, by a Warrant or Warrants, under his hand, to advance and pay out of any monies in the hands of the Receiver-General of the Province, the following sums of money towards defraying the several salaries, allowances and Pensions herein-after specified, for the present year one thousand eight hundred and twenty-three, and in support of His Majesty's Civil Government in this Province, for the year aforesaid, that is to say; To the Speaker of the Legislative Council, a sum not exceeding one thousand pounds, currency; To the Speaker of the House of Assembly, a sum not exceeding one thousand pounds, currency; To the Clerk of the Legislative Council, a sum not exceeding five hundred pounds, currency; To the Clerk Assistant of the Legislative Council, a sum not exceeding four hundred pounds, currency; To the Writing Clerk and French Translator of the Legislative Council, a sum not exceeding two hundred and fifty pounds, currency; To the Law Clerk of the Legislative Council, a sum not exceeding two hundred pounds, currency; To a Master in Chancery, a sum not exceeding ninety pounds, currency; To the Gentleman Usher of the Black Rod, a sum not exceeding one hundred and fifty pounds, currency; To the Serjeant at Arms attending the Legislative Council, a sum not exceeding one Hundred pounds, currency; To the Messenger of the Legislative Council, a sum nor exceeding thirty-six pounds, currency; To the Door-Keeper of the Legislative Council, a sum not exceeding twenty-seven pounds fifteen shillings six pence halfpenny, currency; To the Keeper of the apartments and furniture belonging to the Legislative Council, a sum not exceeding fifty-five pounds, currency; To defray the contingent expenses of the Legislative Council, a sum not exceeding one thousand eight hundred and eighty pounds, seventeen shillings and nine pence, currency; To the Clerk of the House of Assembly, a sum not exceeding five

- II. And be it further enacted by the authority aforesaid, that the monies herein-before mentioned and appropriated, shall be taken from and charged against the general Funds of the Province, arising from any Act or Acts in force therein and from any of the Revenues of His Majesty's applicable to the purposes herein-before mentioned.
- III. And be it further enacted by the authority aforesaid, that the sums of money by this Act appropriated, shall be accounted for to His Majesty, His Heirs and Successors through the Lords
