" for building a County Court House." Passed the 11th March, 1818.

WHEREAS by an Act made and passed in the Fifty-sixth year of His Majesty's Reign intituled, "an Act to autho-"rize the Justices of the General Sessions of "the Peacefor the County of York, to levy an "Assessment, for building a County Court "House," the said Justices are authorized and empowered at any General Sessions of the Peace, or at any Special Sessions for that purpose expressly convened and holden, to make a Rate and Assessment of any sum not exceeding six hundred pounds, as they in their discretion may think necessary, for the purpose of erecting and finishing a Court House for the said County, in the Town of Fredericton;

ton; and whereas since the passing of the said Act, the said Justices have agreed for the purchase of a building already erected, to be used as a Court House for the said County, and it is expedient that the said sum so to be assessed, should be applied to the making of the said purchase for the purpose aforesaid.
