An ACT for the erection of a Court House and Gaol, in the County of Westmorland.

Passed the 20th of March, 1821.

Prezmble.

X THEREAS the Court House and Gaol, in the County of Westmorland, have been lately destroyed by fire: And whereas it is expedient that a Court House and Gaol should be erected in said County---

Be it therefore enacted by the Lieutenant-Governor, Council, and Assembly, That the Justices Justices of the Peace for the said County, at Justices and or Special Session of the Peace hereafter and or Special Session, may contract to be holden, or the major part of them, or building and finat any Special Session for that purpose con- ishing a Gaol and Court House, in vened and holden, be, and they are hereby Dorchester, authorized and empowered to contract and agree with able and sufficient workmen, for building and finishing a Court House and Gaol, in the Town of Dorchester, in the said County, on or near the site of the former buildings, or to appoint Contractors for that or to appoint Contractors for purpose, and to agree for such sum or sums the purpose. of money as to them shall seem meet; and the said Justices are hereby authorized and empowered to make a rate and assessment May raise by saof any sum not exceeding the sum of five not exceeding five hundred pounds, hundred pounds, as they in their discretion may think necessary, for the erecting and finishing a Court House and Gaol in the Town and County aforesaid; the same sum to be assessed, levied, collected and paid, in to be levied, collected, and paid such proportion and in the same manner as at other County any other County rates can or may be assessed, levied, collected and paid, by virtue of an Act made and passed in the twentysixth year of His late Majesty's Reign, incituled "An Act for assessing, collecting, and " levying County rates," or any other Act now or hereafter to be made for the like purpose.
