Geo. 4, c. 19, Reign, intituled, "An Act for granting Bounties on Grain raised on new Land," be, and the same is hereby continued, and declared to be in force until the first day of May, which will be in the Year of our Lord one thousand eight hundred and thirty-three,

CAP. TI.

An Act further to continue until the first day of April one thousand eight hundred and thirty-five, "A. Act to authorize the Justices of the Peace, in their Gene. A Sessions, to establish Ferrics in their respective Counties."
