CAP, VII.

An Act to alter the time of holding the November Term of the Inferior Court of Common Pleas of the County of Gloucester.

HEREAS the time of holding the November Term of the Inferior Court of Common Pleas in and for the County of Gloucester, has been found inconvenient; for remedy whereof,

Be it enacted by the Lieutenant Governor, Council and Assembly, That the said Term of the said Inferior Court of Common Plean heretofore held on the first Tuesday in November, shall hereafter be held on the last Tuesday in October in each and every year; any law, usage or custom to the contrary netwithstanding.

CAP. XII.

An Act for prohibiting and suppressing of Lotteries in this Province.

Passed 17th March 1835.

HEREAS Lotteries have been found by experience to be very injurious to Society, and tend to the great detriment and frequent ruin of minors, mechanics, traders and other unwary persons, by the evil habits engendered and fraudulent practices to which they give rise;

I. Be it enacted by the Lieutenant Governor, Council and Assembly, That all Letteries are and shall be taken and adjudged to

be common and public nuisances.

II. And be it enacted, That no person or persons whatsoever shall publicly or privately exercise, keep open, show or expose to be played at or thrown at, or shall draw, play or throw at any Lottery, either by dice, let, cards, balls, tickets, or any other numbers or figures, or any other way whatsoever; and that every person
