DE it enacted by the Lieutenant Governor, Legislative Council and Assem- Justices in Ses-bly, That the Justices of the Peace for the County of Carleton at any General or Special Sessions of the Peace hereafter to be holden, be and they are ty to pay off debts. hereby authorized and empowered to make such rate and assessment of any sum not exceeding three hundred pounds, as in their discretion they may think necessary for the purpose of paying off the debts of the said County, the same to be levied, assessed, collected and paid agreeably to any Act now or hereafter to be in force for assessing, collecting and levying of County Rates.

#### CAP. XVI.

Passed 19th March 1841.

I. DE it enacted by the Lieutenant Governor, Legislative Council and As-Amdavits men-tioned in 2 Vict. sembly, That the Affidavits mentioned in the second and third sections C. 27, S. 2 & 3 of the said above in part recited Act, having been once made and filed, as pro- not required to be vided by the said Act, shall not be required to be made out and filed from year after being once filed. to year, but such Affidavits respectively shall be deemed sufficient without any further repetition thereof, anything in the said in part recited Act to the contrary. notwithstanding.

The it enacted by the Lieutenant Governor, Legislative Council and Assembly, That the Justices of the Peace for the City and County of Saint John, at any General Sessions of the Peace hereafter to be holden therein, be and they are hereby authorized and empowered to make such rate and assessment of any sum not exceeding two hundred and fifty pounds, as they in their discretion may think necessary for the purpose of paying off the balance due by the said City and County for contingent and other County expenses, the same to be assessed, levied, collected and paid agreeably to any Act or Acts made or to be made for assessing, collecting and levying County Rates.

An Act to establish a Division Line between the Parishes of Northampton and Brighton in the County of Carleton.

CAP. XVIII.

Passed 19th March 1841. HEREAS from the want of a Law establishing a Division Line be-'tween the Parishes of Northampton and Brighton, difficulties and 'disputes have arisen in the assessment of the Inhabitants of the said Parishes 'respectively: Therefore to prevent such difficulties in future,' Be it enacted by the Lieutenant Governor, Legislative Council and Assembly, That the said Line shall commence at the mouth of a certain Creek on the east side of the River Saint John, commonly called and known by the name of Shaw's Creek, and to run from thence a true east course until it strikes the eastern Boundary Line of the County, any Law to the contrary notwithstanding.

Preamble.

Throwing or permitting to be thrown Slabs, Rinds, refuse &c. from Mills between Beaubair's Point and Sheldrake Island, CAP. XIX.

An Act for the better and more effectual securing the Navigation of the River Miramichi, in the County of Northumberland, and to protect the Fisheries on the said River.

Passed 19th March 1841. HEREAS there are extensive Mills for the Manufacturing of Lumber, 'on or near the River Miramichi, between Beaubair's Point and Sheldrake Island, the Slabs, Rinds, and Refuse from which are generally thrown into the said River, whereby the navigation thereof is becoming obstructed and the Fisheries thereon are greatly injured;

I. Be it therefore enacted by the Lieutenant Governor, Legislative Council and Assembly, That from and after the passing of this Act, if any person or persons who may be the owner or owners of any Mill or Mills already erected, or that may be hereafter erected on or near the River Miramichi, between Beaubair's Point and Sheldrake Island, (except as hereinafter mentioned) for the manufacture of Lumber of any description, or any person who may be engaged in manufacturing
